#### 1. Revenue Budget 1996/96

On 22 January 1996 the Corporate Strategy Committee considered a report by the Director of Financial Services on the proposed Revenue Budget for 1996/97. In order to meet the Government's capping criteria the Committee noted that savings were required and agreed policy guidelines and set percentage targets for each service to meet the savings required. Thereafter each Chair and Vice-Chair(s) of all Service Committees met with appropriate Directors to establish how the savings targets could be met and reported back to Special Meetings of all Service Committees.

The Service Committees met on 26 February 1996 and approved the Revenue Estimates for each service along with the package of saving measures required to meet the Government's capping criteria. The Corporate Strategy Committee on 27 February approved the Revenue Estimates for the services of Chief Executive Non-Support and for Joint Boards and the Urban Programme.

Departmental Estimates have now been amended to incorporate non-relevant expenditure e.g. loan and leasing charges and other housing summarised as follows:-

### 2. Determination of Council Tax for 1996/97

After allowing for potential Community Charge income and Aggregated External Finance North Ayrshire Council will require to finance the remainder of its budgeted expenditure from Council Tax. This expenditure of £27.831m will require to be met from Council Tax payers (Appendix N1).
