#### 1. Declarations of Interest

## 2. Minutes

The Minutes of the previous meeting of the Kilwinning Area Committee held on 27 October 2011 were signed in accordance with paragraph 7(1) of Schedule 7 of the Local Government (Scotland) Act 1973.

### 3. Strathclyde Police

Submitted report by Strathclyde Police on the following activity within Kilwinning in the period November and December 2011:-

- Crime/offence statistics for East Kilwinning (Beat 5) and West Kilwinning (Beat 6) for December 2011 compared with the same period in 2010;
- Ongoing action plans to address issues of local concern, including violence, anti social behaviour, acquisitive crime and vandalism;
- Action plans in November and December 2011 which focussed on an increase in theft and vandalism, antisocial behaviour, youth disorder, the purchase of alcohol by youths, test purchasing operations, drug dealing and speeding;

- The outcome of a town centre Environmental Visual Audit undertaken in November 2011, in which partner agencies, the local community, Elected Members and pupils from Kilwinning Academy were involved; and
- The Safer Streets, Violence and Robbery multi-agency plan, which ran from 8 November 2011 until 7 January 2012 and was designed to provide reassurance to Kilwinning residents and businesses over the festive period.

Members asked questions, and received clarification, on the following:-

- Parking issues raised by Kilwinning Community Council in relation to the Main Street:
- The circumstances surrounding recent 'sneak thefts';
- Future Action Plans to tackle anti-social behaviour and housebreaking;
- The value of multi-agency work and the sustainability of Strathclyde Police's current level of commitment;
- The future role of the Police in relation to parking offences; and
- Road traffic issues surrounding ongoing gas works at Garnock View.

# 4. Strathclyde Fire and Rescue

Submitted report by Strathclyde Fire and Rescue on the following activity within the Kilwinning area in the period 1 November to 31 December 2011:-

- 4 accidental dwelling fires during November and December 2011;
- A number of refuse fires, including a number involving wheelie bins being set alight;
- 2 malicious false call alarms:
- An incident involving a driver trapped in a car in 3 feet of flood water;
- 32 Home Fire Safety Visits;
- Ongoing Fire Reach and Work Experience courses at Troon Community Fire Station; and
- Educational visits by Kilwinning Fire Station personnel to James Watt College and St Luke's Primary School, as well as a number of leaflet drops at various retail premises.
