### 1. Strathclyde Police

## 2. Bailey Bridge Replacement: A71 Temporary Closure – Diversion Signing

Submitted report by the Corporate Director (Property Services) on the proposed diversion route signing and the additional traffic management works required to be put in place during works to replace the Bailey Bridge, Irvine.

The A71, which is one of the main arterial routes into the centre of Irvine from the Trunk Road A78, spans the River Irvine by means of the Bailey Bridge. The bridge has been in place for over 37 years and is now subject to width and weight restrictions due to its deteriorating condition. The Council is planning to replace the bridge on a permanent basis which will require an extended road closure. The special Council meeting on 12 February 2009 will consider a recommendation from the Executive to identify the additional funding to take the project forward.

Information was provided on the detailed roads diversions and road safety and traffic management measures which will be put in place to facilitate the temporary closure of the A71, between Milgarholm roundabout and Merryvale roundabout. A public exhibition to explain the diversion routes and other additional road safety measures will take place in due course.

# 3. Local Development Plans

Margaret Ferrier, Team Leader (Development Plans) presented the Committee with information on the new Local Development Plan process.

The Planning etc (Scotland) Act 2006 terminated the two tier planning system in Scotland. The Act introduced new Local Development Plans (LDPs), which are designed to make planning faster and more inclusive. Within North Ayrshire, a new LDP will replace the Ayrshire Joint Structure Plan and the Council's two existing Local Plans. The anticipated timescale to introduce the new LDPs is as follows:-

- Main Issues Report produced (late 2009)
- Proposed Plan produced (late 2010)
- Examination of Plan by Reporter (2011/12)
- Adoption of Plan (2012/13)

A Local Development Plan Committee, comprising all elected Members, has been established to take forward the new Plan. The Area Committee will have the opportunity to feed in to the process.
