1. Gaming Act 1968

2. Public Charitable Collections

Submitted report by the Assistant Chief Executive (Legal and Protective) on proposed new procedures for dealing with public charitable collections in North Ayrshire.

Section 119 of the Civic Government (Scotland) Act 1982 authorises the local authority in whose area a collection is to be held, to grant permission to the body or charity organising the event. The grounds on which an authority can refuse to grant an application are very limited. Once granted the collection must be undertaken in accordance with the Public Charitable Collections (Scotland) Regulations 1984 as amended. These Regulations control such issues as the authorisation of collectors, the types of collection tins, the conduct of the collection and the accounts and returns to be submitted.

Applications for public charitable collections fall into two separate categories of exempt and non-exempt. Exempt charities are those recognised by the Scottish Executive as being charities which operate throughout Scotland. Thirty charities come within this definition and these charities have an automatic right to carry out a collection on the day of their choice subject to giving the licensing authority three months notice. All other charities must give a minimum of one months notice and may only collect if authorised to do so by the local authority.

The processing of applications for public charitable collections in North Ayrshire has been carried out in the same way since the Act came in to force. The Member/Officer Working Group on the Civic Government (Scotland) Act 1982: Licensing Review has now reviewed the existing procedures and made recommendations, as set out in the appendix to the report, in terms of future arrangements to deal with public charitable collections. These new arrangements include the introduction of a computer based system to process and track applications, the introduction of a new application form that will expand to 16 the number of areas in which a charity may choose to collect, limits on how far in advance of the date requested an application for a collection can be received, arrangements for notifying elected members of collections in their wards, clarification on the definition of 'new' charities and the treatment of applications from new charities, the introduction of new guidance notes which will amongst other things remind charities of the requirement to submit accounts, and the redrafting of the Permission document issued in respect of public charitable collections.

The Sub Committee agreed to adopt the procedural rules for public charitable collections as set out in the appendix to the report.

3. Exclusion of Public

The Sub Committee resolved, in terms of Section 50(4) of the Local Government (Scotland) Act 1973, to exclude from the Meeting the press and the public for the following items of business on the grounds indicated in terms of Paragraphs 6, 13 and 14 of Part I of Schedule 7A of the Act.

4. Civic Government (Scotland) Act 1982: Taxi Driver and Private Hire Car Driver Licences

Submitted report by the Assistant Chief Executive (Legal and Protective) on proposed variations of licensing conditions attached to taxi driver and private hire car driver licences presently in force.

In terms of the procedure to deal with variations to licences, the Council as Licensing Authority is required to grant a Hearing to each licence-holder to consider any representations they may have in respect of any proposed variation to the conditions attached to their licence. 191 licence-holders, as set out in the attached Appendix LS1, were cited to attend the meeting. The holder of taxi drivers licence TDL/750 was present at the meeting and was heard by the Sub Committee.

The Sub Committee agreed to vary the conditions attached to 162 taxi driver licences and 29 private hire car drivers presently in force, as set out in the attached Appendix LS1, in accordance with Paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act 1982.

5. Civic Government (Scotland) Act 1982: Applications for Licences

Submitted report by the Assistant Chief Executive (Legal and Protective) on (a) applications for the grant or renewal of licences; (b) issues in respect of existing licence holders which may require a Hearing; and (c) Hearings which require to be determined by the Sub Committee.

The Sub Committee agreed to dispose of these matters as indicated in the attached Appendix LS2.

The applicant having been duly cited was present at the Hearing.
