2. Garnock Valley: 09/00864/PP: Beith: Glengarnock: 21 Grahamston Avenue

Submitted report by the Chief Executive on a request for a review of the decision taken by officers under delegated authority to refuse planning permission for the erection of 8 dwellinghouses with associated access road and car parking, including the demolition of the existing building at 21 Grahamston Avenue, Glengarnock, Beith. The Notice of Review documentation, the Planning Officer's Report of Handling, a location plan and copy of the Decision Notice, were provided as Appendices 1-4 to the report.

The Planning Services Manager, as Planning Adviser to the LRB, introduced the matter under review, confirming that the Notice of Review was in order and had been submitted timeously by the applicant. Photographs and plans of the site were displayed.

Members expressed the view that the Local Review Body required further information and clarification on the issue of flooding risk before moving to determine the Notice of Review. It was noted that a consultation response from SEPA had been received on 24th February 2010.

The Local Review Body agreed (a) to continue consideration of the Notice of Review to a future meeting for a hearing to be conducted in terms of the Hearing Session Rules set out in Schedule 1 of the Town and Country Planning (Schemes of Delegation and Local Review Procedure) (Scotland) Regulations 2008, to examine further the issue of flooding risk and the terms of the consultation response from SEPA; and (b) that the applicant/applicant's representative, a representative of the Council's Infrastructure and Design Services (Flooding) and a SEPA representative be invited to attend and address the hearing in relation to those issues.

3. Garnock Valley: 10/00089/PPP: Beith: Glengarnock: 3 Balgray Road

Submit report by the Chief Executive on a request for a review of the decision taken by officers under delegated authority to refuse planning permission in principle for a residential development at 3 Balgray Road, Glengarnock, Beith. The Notice of Review documentation, the Planning Officer's Report of Handling, a location plan and copy of the Decision Notice, were provided as Appendices 1-4 to the report.

The Planning Services Manager, as Planning Adviser to the LRB, introduced the matter under review, confirming that the Notice of Review was in order and had been submitted timeously by the applicant. Photographs and plans of the site were displayed.

4. North Coast and Cumbraes: 09/00855/PP: West Kilbride: Seamill: 39 Ardrossan Road: Seamill Hydro Hotel

Submit report by the Chief Executive on a request for a review of the condition imposed by officers under delegated authority in respect of planning permission for the redesign of flats, formation of 2 new windows to Block 'C' and enlargement of existing windows at the Seamill Hydro Hotel, 39 Ardrossan Road, Seamill, West Kilbride. The Notice of Review documentation, further representations received from interested parties, the applicant's response to the representations, the Planning Officer's Report of Handling, a location plan and copy of the Decision Notice, were provided as Appendices 1-6 to the report.

The Planning Services Manager, as Planning Adviser to the LRB, introduced the matter under review, confirming that the Notice of Review was in order and had been submitted timeously by the applicant. Photographs and plans of the site were displayed.
