North Ayrshire's Children's Literacies and Arts Section will provide opportunities for the musicians, composer and singers to observe and be involved in the script development process, gaining a sense of characters, story, colours, style and developing the sound world. Work requires to commence as soon as possible to allow the various partners and writers to be involved; ready to commence with the young people at the start of the new session. The group should put the balance of £34 towards this project.

12. How will the expenditure develop the group/organisation and benefit the local community?

The idea is to create a Scots language opera/music theatre piece aimed at and part created by around 60 school pupils in Largs. Using the North Ayrshire Council owned picture 'Waurs Oor Wullie' inspired by the Largs Viking Festival as a stimuls, the pupils will work on a project to create a scots language story and opera libretto that will be set to music and performed by Ayrshire Opera Experience in a special schools performance as part of the 2015 Largs Viking Festival in August/September. All pupils form Largs will be invited to the performance.

13. How does the application show innovation or development?

The aim of the project is to create a piece of art that gives young people and a wider audience the chance to experience an art form that they may not otherwise engage with. This would provide a unique and innovative way of promoting and teaching scots language. The final outcome would be a theatrical engaging performance of the opera.

14. Overall assessment?

Ayrshire Opera Experience is a new arts organisation dedicated to creating opportunities for communities to get involved in opera and arts. They are the first group to have had an opera translated into scots language and performed in Ayrshire. This new project is important for the company to continue to progress and grow. They are committed to producing high quality arts projects in Ayrshire, working with talented local artists and providing a platform and additional training to local young people.
