Inspector Conway reported on Police activities in the Committee's area. Statistical information on the beats within the Irvine areas was provided:-

Beat 1 - 647 incidents in total (27 assaults and no robberies)

Beat 2 - 1519 incidents in total (70 assaults and 4 robberies)

Beat 3 - 377 incidents in total (11 assaults and no robberies)

Beat 4 - 1209 incidents in total (41 assaults and 2 robberies)

The Committee was advised that details of the police officers assigned to each area within Wards 1 and 2 will be circulated to Members.

Submitted report by Strathclyde Fire and Rescue on activity in the Irvine area between 1 February and 15 March 2011.

Greenwood Academy pupils will be provided with a presentation and an open day will be held to enable the community, and local Councillors, to view the facilities of Dreghorn Fire Station including the real fire training units.
