1. Civic Government (Scotland) Act 1982: Public Entertainment and Indoor Sports Entertainment Licensing

Submitted report by the Assistant Chief Executive (Legal and Protective) on the recommendations arising from the Member/Officer Working Group on Civic Government (Scotland) Act 1982: Licensing Review, relating to Public Entertainment and Indoor Sports Entertainment licensing.

A partial review of the public entertainment licensing system was carried out in 1997 and concentrated primarily on major events, as the existing system was proving inadequate to meet the demands of this type of application. It also dealt with the fees and some areas of the consultation process. Apart from that, the system presently in use has remained substantially unchanged since its commencement.

The Member/Officer Working Group met on 17th December 2002 to review Public Entertainment and Indoor Sports Entertainment licensing. The report highlighted the recommendations arising from the review relating to a proposed new fees structure, changes in the format of application forms and information notes, a proposal to notify the Health and Safety Executive of all applications received for fairgrounds, and proposed changes in general licensing conditions. The proposed amendments aim to provide better guidance to applicants and clarity for licence holders, whilst the revision of the fee structure will enable the licensing authority to comply with the statutory requirement that the costs of operating the system are met by the application fees charged.

The Sub-Committee agreed (a) to implement the proposed new fees structure with effect form 1st April 2003; (b) that the application forms for licences and information notes for public entertainment [permanent], public entertainment [fairground, circus, temporary event], public entertainment [major event] and indoor sports entertainment be amended as set out in the report; (c) that the Health and Safety Executive National Fairground Inspection Unit in future be advised of all applications for fairground licences lodged; (d) that the general conditions to be attached to licences be amended as set out in the appendices to the report; and (e) that the Chief Legal Officer (District Court & Licensing) attach appropriate conditions to licences for temporary major events, other temporary events as required and temporary Indoor Sports Entertainment licences.

2. **Gaming Act 1968**

Submitted report by the Assistant Chief Executive (Legal and Protective) on an application received under Section 34 of the Gaming Act 1968 for permits for gaming machines.

The licence holder and the complainant's representative both addressed the Hearing before withdrawing, together with the Solicitor (Licensing), to allow the Sub Committee to deliberate. All parties thereafter returned to hear the Sub Committee's decision.

Decision

The Sub Committee unanimously agreed in terms of Paragraph 11 (11) of Schedule 1 of the Civic Government (Scotland) Act 1982, to suspend the licence for a period of 6 months.
