Purpose: To advise cabinet of the result of the tender exercise for the Contract for Watt Court Sheltered Housing Unit Redevelopment

Recommendation: Agree to approve the award of Contract for Watt Court Sheltered Housing Unit Redevelopment to Ashleigh Scotland Limited

1. Executive Summary

- 1.1 North Ayrshire Council requires to establish a new contract for Watt Court Sheltered Housing Unit Redevelopment.
- 1.2 In order to comply with the Council's Standing Orders Relating to Contracts and Contract Procedure Rules and Public Contracts (Scotland) Regulations 2015 (SSI 2015/446) (as amended) a formal tendering exercise was undertaken.
- 1.3 The contract term is 114 weeks with the proposed award to Ashleigh Scotland Limited

2. Background

- 2.1 A formal contract notice was advertised on 14th November 2017 under the Open procedure in the Official Journal of the European Union and Public Contracts Scotland Procurement Portal and the procurement exercise was carried out via the PCS-Tender E-Tendering System. The return date for the ITT was 16th January 2018 at 12 noon.
- 2.2 The contract notice attracted 14 expressions of interest from a range of potential suppliers of which 5 submitted a response to the Invitation to Tender.
- 2.3 The evaluation of tenders was undertaken using the following stated criteria: most economically advantageous tender using a price quality ratio of 80% Price / 20% Quality.

3. Proposals

3.1 It is proposed that the Contract is awarded to Ashleigh Scotland Limited.
