### 1. Chair's Remarks

The Chair welcomed all of those present to the first meeting of the Educational Services Committee of North Ayrshire Council.

### 2. Membership of the Educational Services Committee

Submitted report by the Corporate Director (Educational Services) on additional categories of membership of the Educational Services Committee.

The Committee (a) noted that the Church of Scotland and Catholic Church appointments were Mrs Christine Welch and Father Matthew McManus respectively; and (b) agreed (i) to place an advertisement in local papers inviting churches and denominational bodies in North Ayrshire to nominate a person to serve as the third church representative on the Educational Services Committee; (ii) to invite the Joint Consultative Committee for teaching staff to nominate one member currently serving in a North Ayrshire school to act as the representative of the teaching profession on the Educational Services Committee; and (iii) to consult School Boards in North Ayrshire in order to identify one parent to serve on the Educational Services Committee.

### 3. HMI Inspection Reports

Submitted reports by the Corporate Director (Educational Services) on the outcome of inspections by Her Majesty's Inspectors (HMI) at (a) James McFarlane School, Ardrossan; (b) Ardeer Primary School and Nursery Class, Stevenston; and (c) St Mark's Primary School, Irvine.

The Committee agreed the proposals detailed in the reports to address the recommendations of the HMI Inspection Reports.

#### 4. Award of School Transport Contracts

Submitted reports by the Corporate Director (Educational Services) on tenders received in respect of transport contracts for (a) mainstream schools; and (b) children with medical and/or special needs.

The Committee discussed the operational aspects of mainstream school transport and the need to examine the issue further.

The Committee (a) with regard to mainstream school transport contracts (i) agreed (A) the award of contracts as detailed in the report; and (B) that a Working Group be appointed to consider school transport issues; and (ii) noted that the Chair and a Head of Service (Educational Services) will meet with Strathclyde Passenger Transport to discuss these contracts; and (b) with regard to school transport contracts for children with medical and/or special needs agreed (i) to award the contracts as detailed in the report; (ii) that two contracts be awarded to one firm who submitted multiple bids which were the lowest tenders; (iii) that in two instances contracts be awarded to firms whose offer was equal lowest with other contractors; and (iv) that nine contracts be re-advertised and awarded and the outcome reported to the Committee in due course.

#### 5. Arran Community Learning Centre

Submitted report by the Corporate Director (Educational Services) on the proposed development of a Community Learning Centre on Arran in partnership with Argyll College and James Watt College.

The Committee agreed (a) in principle, to the lease to Argyll College of an area of ground adjacent to the Community Education office at Lamlash High School, Arran; and (b) that the matter be referred to the Corporate Services Committee for its consideration.

#### 6. Funding of Pre-School Education

Submitted report by the Corporate Director (Educational Services) on funding arrangements for Pre-School Education in 1999/2000.

The Committee agreed (a) the arrangements for commissioning nursery places from the private and voluntary sectors; and (b) the arrangements for assisting private and voluntary sector groups in the provision of nursery education.

#### 7. Adult Learners Week 1999 Awards

Submitted report by the Corporate Director (Educational Services) on the success of the "Family Cooking Group" from North Ayrshire at the recent Adult Learners Award Ceremony.

The Committee agreed (a) to congratulate the "Family Cooking Group" on their award as overall winners from all entrants in the Scottish Television area; and (b) that the Chair and Vice-Chair or their nominees visit the parents and children involved.

#### 8. Appointments to Trusts and Other Bodies

Submitted report by the Corporate Director (Educational Services) on the appointment of Members of the Council to Trusts and Other Bodies.

### 9. Kilwinning Rangers: Abbey park

Submitted report by the Corporate Director (Educational Services) on future management arrangements for Abbey Park, Kilwinning.

The Committee discussed the situation regarding Junior Football Clubs re-acquiring their grounds by lease or purchase. The former Community and Recreational Services Committee had considered this matter in January 1999 and agreed to continue discussions to a future meeting of the Committee.

The Committee agreed (a) to the lease of Abbey Park to Kilwinning Rangers Football Club on terms to be agreed between the Club and the Council; and (b) noted that a report on other Junior Football Clubs' grounds will be submitted to a future meeting.

#### 10. Dreghorn and Broomlands Bowling Club: Extension of Lease

Submitted report by the Corporate Director (Educational Services) on a request by the Dreghorn and Broomlands Bowling Club to extend the lease of the bowling green by another 25 years and to approve proposals for an extension to the clubhouse, subject to the necessary planning and building consents being received.

The Committee agreed to the extension of the lease to the Dreghorn and Broomlands Bowling Club and the proposed clubhouse development.
