# 1. Appointment of Chair

The Committee agreed that Councillor Hunter assume the Chair for the duration of the meeting.

### 2. Declarations of Interest

In terms of Standing Order 10 and Section 5 of the Code of Conduct for Councillors, Councillor McNamara, as a volunteer with the Group, declared an indirect financial interest in Agenda Item 12.2 (North Ayrshire Council (Ardrossan) Charitable Trust: Application for Financial Assistance) in relation to the grant application by Ardrossan Music Experience.

#### 2. Minutes

The accuracy of the Minutes of (i) the special meeting held on 11 August 2015 and (ii) the ordinary meeting of the Committee held on 17 September 2015 was confirmed and the Minutes signed in accordance with Paragraph 7 (1) of Schedule 7 of the Local Government (Scotland) Act 1973, subject to the amendment in item 3 of the Minute of the meeting held on 17 September, that the parking issues relate to Dockhead Street and Hamilton Street, Saltcoats, rather than Windmill Street and Hamilton Street.

# 3. Presentation: National Attainment Challenge: North Ayrshire Strategy

The Committee received a presentation by the Executive Director (Education and Youth Employment) on the National Attainment Challenge and on providing transformational change within North Ayrshire schools through the introduction of a professional learning academy rationale.

Members asked questions and were provided with further information in relation to:-

- reconstructing and redesigning the education workforce to enable the delivery of long term support for children and families;
- providing a breakdown on deprivation levels for the Three Towns area; and
- potential funding which will be available from the Scottish Government.

The Executive Director undertook to present information to the Area Committee at a future date on deprivation levels in relation to the Three Towns area.

Station Manager Elliot advised that he would speak to colleagues to ascertain any areas of concern regarding obstruction to fire vehicles in the Sidney Street area.

# 6. Arran Economic Group

Members intimated that Ardrossan Harbour was an area which could benefit from Government funding for redevelopment and the Project Officer undertook to pass on the views of the Committee.

The Committee noted the work of the Arran Economic Group including the appointment of an Arran Development Director.

# 7. Sustainable Waste Management - Arran

Submitted report by the Executive Director (Place) on the progress being made in developing a suite of sustainable waste management options for Arran.

Members asked questions and were provided with information in relation to:-

- difficulties in calculating the breakdown between household and commercial waste:
- costs associated with the installation of a weigh bridge facility at the Brodick transfer station; and
- the locations of the 10 recycling points on Arran.

The Committee noted the progress being made in developing a suite of sustainable waste management options for Arran.

# 8. Winter Service and Weather Emergencies Plan 2015

This successful event is the result of the early death of the group's co-founder Mr Colin McCallum, who had a dream of organising a better organised and run event than he had ever encountered over the years of taking young people around the local competitions.

The group have achieved two successful trips to Barga, Italy - utilising the close contacts between Saltcoats and the Italian town. They also attended a trip to the Spanish Festival in 2014 and had a personal meeting with the Queen and Prince Philip in Balmoral in 2015.

They attend numerous parades, galas, fetes and performances throughout North Ayrshire and beyond, including Saltcoats Gala and Whitlees Gala; annual Armistice Parades in both Ardrossan and Saltcoats; santa parades in Saltcoats and Ardrossan; successful collaboration with Millport Pipe Band, which allowed both groups to compete at surrounding Highland Games, culminating in their first ever competition win at Ardrossan Highland Games in 2012.

# 13. How does the application show innovation or development?

This application shows innovation as it is unique in that they offer age specific categories (i.e. 10 years and under, 11 years and under, 12 years and under etc to the age of under 19 years), rather than age group categories. The Arran High School Mountain Bike Club formed in 2014 after Active Schools, working with key partners in the school, successfully applied to participate in Cycling Scotland's Annual School Residential Camp. This is a 5-day camp at which participants develop project ideas, create an action plan and gain:

- Cycle Training Assistant Qualification
- Cycle Maintenance Level 3 (City & Guilds)
- First Aid Qualification (SQA)

Arran High School was one of only 9 schools in Scotland to be accepted on to this camp in 2014 and the only North Ayrshire school.

In 2015, on the back of all the developments which the school has delivered, Arran High School once again took part in the camp, (along with pupils from Ardrossan Academy).

The club now has a regular 20 participating in the twice weekly sessions, and has launched Scotland's first girls only mountain biking group.

As well as developing their technique as mountain bikers, members of the club also learn essential cycling maintenance sills as this is an activity which often takes place in remote and isolated locations.

In another development, the club is working with the Forestry Commission Scotland and other partners to develop an MTB Skills Park in Lamlash.

Arran High School Mountain Bike Club is an excellent example of a capacity building opportunity which arose directly from a National Governing Body of Sport (in this case Cycling Scotland). Finance & Corporate Support have reviewed the application and have no objections from a finance perspective.

## Legal

In terms of Section 15(4) of the Local Government (Scotland) Act 1994 when determining whether an application should receive assistance from Common Good funds the Committee should have regard to the interests of the inhabitants as a whole of the area to which the common good relates.

Legal note from the application that funding has been requested to cover the fees of the various licences required to broadcast in the three towns area. The broadcasts are aimed at all sectors of the community, local people are involved in the production of programmes and community groups are afforded the opportunity to promote their work on air and have done so. Legal are of the view that as the radio service benefits the whole community a grant can be justified.

If the committee is minded to award a grant Legal would ask that the benefit to the whole community is clearly minuted as it is likely that the auditor will require this information.

## **Economy & Communities**

3TFM have engaged over 400 local people as volunteers since they began broadcasting, many of whom have gone onto work or into FE or higher education. The volunteers are taught how to produce programmes for the community, and work with local people, schools while training and transforming the lives of 150 young volunteers every year.

As the application covers young people and residents from both Saltcoats and Stevenston this application could be shared between the Stevenston and Saltcoats Common Good funds.

Economy and Communities are supportive of this application. Licence fees are expensive and without them, the station could not continue to undertake to broadcast or engage with the three towns communities.

- 1.1 North Ayrshire Council previously approved the establishment of Charitable Trusts at its meeting in January 2012. A subsequent report was submitted to the Committee on 28 November 2013 outlining the proposed procedure for considering applications and grants from the Trust.
- 1.2 The funds held in each Trust across North Ayrshire are held in separate sub-funds for the following 3 purposes:-
  - Α the prevention or relief of poverty.
  - В the provision of recreational facilities, or the organisation of recreational activities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended, and
  - С the relief of those in need by reason of age, ill-health, disability, financial hardship or other disadvantage.
- 1.3 In the case of the Ardrossan Trust, funds are held for purpose A - the prevention or relief of poverty, and for purpose C - Age/III Health/Disability.
- 1.4 The Executive Director (Finance and Corporate Support) confirmed to the Cabinet on 20 April 2015 that the amount available for disbursement from the Ardrossan Charitable Trust for 2015/16 is £44 (£21 for Poverty and £23 for Age/III Health/Disability).

# 2. Background

The application meets the criteria of Purpose B, as it is for the provision of recreational facilities and the organisation of recreational activities with the object of improving the conditions of life for the persons for whom the activities are primarily intended, in this case young persons.

The application can therefore be granted as it meets one of the Trust Purposes, provided the Trustees are satisfied that granting the application will be a beneficial use of the trust funds in achieving the main purpose of relief of the poor. It should also be noted that the amount requested (although not stated at section 3 of the application) appears to be in excess of the annual income available for distribution from the Trust. ## Legal

The application meets the criteria of Purpose B, as it is for the provision of recreational facilities and the organisation of recreational activities with the object of improving the conditions of life for the persons for whom the activities are primarily intended, being persons on low income who might otherwise be unable to take part in such activities. It could also be argued that it meets Purposes A and C, particularly the latter which makes specific reference to relief of those in need by reason of financial hardship. However, this is less clear and I think Purpose B seems the most appropriate.

The application can therefore be granted as it meets one of the Trust Purposes, provided the Trustees are satisfied that granting the application will be a beneficial use of the trust funds in achieving the main purpose of relief of the poor.
