1. Declarations of Interest

There were no declarations of interest by Members in terms of Standing Order 16 and Section 5 of the Councillors Code of Conduct.

2. Minutes

The accuracy of the Minutes of the Meeting of the Committee held on 2 October 2014 was confirmed, subject to the correction of a minor typographical error at the end of the second paragraph of Item 5 (Cumbrae Fuel Facility: Update), to read "...it would not be in a position to pursue such a project on behalf of the community". Thereafter, the Minutes were signed in accordance with Paragraph 7 (1) of Schedule 7 of the Local Government (Scotland) Act 1973.

3. CPP Partners

3.1 Police Scotland

The Committee noted that, on this occasion, a Police Scotland representative was not in attendance.

3.2 Scottish Fire and Rescue Service

Submitted report by the Scottish Fire and Rescue Service on incidents within the North Coast area during the period 17 September to 9 November 2014.

The report included information on the following:-

- a number of accidental dwelling fires;
- the low number of rubbish fire incidents, particularly given that the reporting period included 5 November;
- the relatively high incidence of good intent and equipment false alarm calls; and
- special service activities, including in relation to flooding at Glen Grove, Largs, and an open fire hydrant on Cumbrae.

Further details were provided at the meeting on the following:-

- action being taken, in partnership with the Council, to reduce the number of call-outs to sheltered housing; and
- attendance at a recent meeting of the new Largs Resilience group to discuss partnership working.

Members discussed the following:-

- the flooding at Glen Grove, Largs;
- the background to call-outs to sheltered housing accommodation; and
- whether the number of good intent and equipment fault incidents relating to Cumbrae merited some awareness raising activity on the island.

The Committee noted (a) the potential for Cumbrae Community Development Company to liaise with the Scottish Fire and Rescue Service on awareness raising activity surrounding good intent and equipment faults on the island; and (b) the content of the report.

4. Winter Service and Weather Emergencies Plan 2014

Submitted report by the Executive Director (Place) on the Roads Winter Service and Weather Emergencies Plan 2014 in relation to the Council's statutory duties under the Roads (Scotland) Act 1984.

Members discussed the following:-

- where authority lies for any decision to close the trunk road from Largs to Skelmorlie due to bad weather;
- whether there have been any major changes to the Plan in light of resource pressures;
- whether the Service has liaised with the new Largs Resilience group to discuss partnership working
- the need to dispel the myth that residents clearing footpaths of snow and ice might open themselves up to any legal action; and
- the provision of sand and sand bags on Cumbrae.

The Assistant Network Manager undertook to (a) liaise with the Largs Resilience group to discuss the potential for some partnership working in relation to the Winter Service and Weather Emergencies Plan; and (b) place information on the Council's website about the legal position as regards residents and local communities clearing local footpaths and roads of ice and snow.

Noted.

5. Building Names for Day Care Centre and block of flats at former Stevenson Institute site

Submitted report by the Executive Director (Economy and Communities) on the naming of a block of flats and the new day care and resource centre located on the site of the former Stevenson Institute at Lade Street, Largs.

The Committee agreed that the flatted development and the day care and resource centre be named "Stevenson Court" and "Stevenson Day Care and Resource Centre", respectively.

6. Largs Sea Front Car Park: Update on Projects and Car Park Usage

Submitted report by the Executive Director (Place) which provided information on the implementation of agreed projects, and the usage of Largs Sea Front Car Park between June and August 2014.

Members discussed the following:-

- progress with the Largs Masterplan and whether local Members would have sight
 of a draft of the plan prior to formal consideration by the Area Committee;
- Transport Scotland's position on the use of alternative paving within the town centre and its subsequent maintenance;
- the potential availability of funding from EDF for the provision of cycle racks;

- the importance of seeking to create a sense of balance between the improvements to the narrower south and wider north side of the Main Street;
- the need for further works to Haylie Brae picnic area to address a dip between the surface level of the car park and the path leading up from it;
- the value of providing a large sign at the entrance to the town, allowing the Viking Festival and other local events to be highlighted; and
- the success of the parking arrangements during this year's Viking Festival.

The Committee agreed that (a) the Team Manager (Regeneration) liaise informally with local Members on the options within the draft Largs Masterplan before the final document is submitted to the Area Committee; and (b) the Acting Streetscene Manager seek to pursue (i) the potential for EDF funding for cycle racks, (ii) the surface levelling works identified in relation to the Haylie Brae picnic area and (iii) the provision of a large sign at the entrance to Largs which might allow the Viking Festival and other local events to be highlighted to visitors.

7. Town Centre Parking Strategy

Submitted report by the Executive Director (Economy and Communities) on the Town Centre Parking Strategy as it relates to Largs. Appendix 1 to the report listed the actions to be taken forward within Largs.

Members discussed the following:-

- the need to revisit the 2012 traffic survey given changes to the number of available parking places within the town centre; and
- the importance of seeking to develop further car parking sites within Largs.

The Committee agreed (a) to note the actions to be undertaken and the proposed timescales; and (b) that local Members liaise directly with the Supervisory Engineer should they have (i) any issues in relation to bus stops and (ii) suggestions as to the location of further Electric Vehicle Charging Points, subject to the availability of further funding.

8. Quality of Housing: Private Rented Sector, Largs

Submitted report by the Executive Director (Place) on current and potential interventions to address poor quality private rented accommodation within Largs.

The Principal Officer (Strategy) provided a verbal update on (i) the consultation arrangements relating to a Private Sector Condition Strategy referred to at Section 1.5 of the report and (ii) the planned deployment of the Multi-Agency Problem Solving Group to Largs over a six-week period.

Members discussed the following:-

- the work of the Multi-Agency Problem Solving Group, including the targeting of dog fouling;
- the lack of improvement grants to support the maintenance of properties;
- the need to gather evidence in relation to poor environmental standards and other information which might support an application for an Enhanced Enforcement Area;
- the value of concentrating available resources on surveying the condition of part of a street in Largs where there are concerns about the condition of private rented housing; and
- the Council's powers in terms of Rent Penalty Notices.

The Committee agreed (a) that the Principal Officer (Strategy) liaise with local Members to identify part of a street within Largs where the limited resources available could be focussed in terms of condition survey work; and (b) otherwise to note the content of the report.

9. Millport: Regeneration and Community Engagement

Submitted report by the Executive Director (Economy and Communities) on progress with regeneration projects in Millport and a proposed approach to develop a refreshed local economic action plan.

The Team Manager (Regeneration) provided a verbal update on the timing of the planned facilitated workshop, which is likely to take place in February 2015.

Members discussed the following:-

- the importance bringing together the various actions plans and identifying priorities;
- plans for a facilitated workshop involving all local partners and relevant/appropriate agencies;
- the legal position on the transportation and domestic storage of combustible materials: and
- issues in relation to the provision of a community fuel facility, including the Cumbrae Community Development Company Board's intention to give further consideration in the new year to the matter, including seeking to identify suitable land, grants and local groups which might allow the project to progress.

The Committee agreed (a) to note progress made with regeneration projects in Millport; and (b) to the proposed approach to develop a refreshed local economic action plan including local groups and stakeholders and other relevant agencies and organisation.

10. Community Development Grant Scheme and Local Youth Action Fund: Application for Financial Assistance

Submitted report by the Executive Director (Economy and Communities) on applications received in respect of the Community Development Grants Scheme.

The Committee agreed to (a) make an award of £146.02 to The Ayrshire Community Trust (TACT) from the Community Development Grants Scheme; (b) refuse the application from Cumbrae Primary School Parent Council, on the grounds that it does not meet the grant criteria; and (c) that officers seek to direct Cumbrae Primary School Parent Council to other potential sources of funding to cover transport costs.

11. Largs Common Good

11.1 Matter Arising from the Previous Meeting: Applications for Financial Assistance

Submitted report by the Chief Executive on further information received in respect of applications for financial assistance considered by the Committee at its meeting on 2 October 2014.

At its last meeting, the Committee agreed to continue consideration of applications from Largs Bowling Club and Douglas Park Bowling Club, pending the provision, either in person or in writing, of (i) further information on how an award would benefit the community as a whole and (ii) three quotes for the planned work. Appendix 1 to the report outlined the applications received and the additional information provided by the groups was set out at Appendices 2 and 3 to the report.

Representatives of Largs Bowling Club attended the meeting and provided further information on the club's diverse membership, community activities and work with local schools.

The Committee agreed to make awards of £2,000 and £1,745 to Largs Bowling Club and Douglas Park Bowling Club, on the basis that both groups actively encourage the participation of the wider community and undertake a variety of activities which benefit the residents of Largs as a whole.

11.2 Application for Financial Assistance

Submitted report by the Chief Executive on an application for financial assistance received in respect of Largs Common Good.

The Committee agreed to make an award of £300 to the St Vincent de Paul Society.

12. Future Chairmanship of the Area Committee

The Committee considered arrangements for the future chairmanship of the Area Committee, pending the conclusion of the period of appointment of the current Chair.

The Committee agreed to recommend to the Council that (a) Councillor Gallagher be appointed to Chair the Area Committee for the period 1 January 2015 to 29 February 2016; and (b) thereafter, Councillor McLean be appointed as Chair for the remainder for the current Administration.

13. Date and Venue of Next Meeting

The next meeting of the Area Committee will be held on 22 January 2015 in Largs Library.

14. Future Agenda Items

The Committee agreed to (a) request that the Executive Director (Economy and Communities) submit a report to a future meeting on the potential for the compulsory purchase of the Stable building within the grounds of Garrison House, Millport; and (b) note that Members should advise Committee Services of any further potential items for inclusion on a future Agenda.

Chair

Councillor Gibson in the Chair.

1. Welcome and Apologies

The Chair welcomed those present to the meeting and a special welcome was extended to Allan Stewart, Scottish Fire and Rescue Service, who has recently been appointed as Head of Response and Resilience for North Ayrshire

2. Minutes of Previous Meeting

The minutes of meeting held on 4th September were approved.

3. Matters Arising from Minutes

Submitted note of action taken on matters arising from previous meeting on 4th September.

In relation to access to healthcare John Burns advised that meeting arrangements were being made in order to discuss a manager from Strathclyde Partnership for Transport joining the Strategic Board.

4. Early Intervention & Prevention

(a) Early and Effective Intervention and Youth Justice

Mark Inglis, Senior Manager (Specialist Support), North Ayrshire Council provided a presentation on the Early and Effective Intervention approach used in Youth Justice.

Discussion followed on:

- Public perceptions of dealing with young people with a diversionary instead of punitive approach
- Benefits in later life of young people not having a criminal record

 A change in culture amongst police officers following the adoption of this approach

The Board recognised the Early and Effective Intervention approach as having a clear impact on outcomes for young people.

(b) Early Years Collaborative

Report submitted by Marjorie Adams on the Early Years Collaborative. This provided an update on the national sessions as well as local tests of change being undertaken.

The Board discussed the aim of 90% of children meeting developmental milestones and that these targets exclude those who have additional support needs.

There was also discussion on:

- The impact and benefits of using ipads within Early Years settings
- Changes in methodology in assessing children's development
- The need to target tests of change appropriately in order to close the inequality gap in outcomes for children

John Burns commended the work of the Early Years Collaborative and advised that the power of this approach was to scale up successful tests of change.

The Board approved the proposals for further testing, requested that future update reports be provided and that information be provided on how the tests of change can be replicated in order to achieve a greater impact.

5. Working North Ayrshire

Universal Credit

The Board received a presentation on Universal Credit from Stephen Humphries (North Ayrshire Council) and Liz McCreadie (DWP). This provided an overview of Universal Credit with particular focus on the role of CP partners in delivery and support.

Discussion followed on:

- The amount of uncertainty about timings and detail of provisions
- The pressures of accelerating our partnership approach to meet changing timescales
- The resource required by CP partners to support claimants
- Undertaking a child poverty impact assessment

Local work to develop a vulnerability matrix for council tenants was discussed, along with the role of the Money Matters team in supporting vulnerable people within the wider Health and Social Care Partnership.

Elma Murray advised the Board of a recent planning meeting in relation to the roll-out of Universal Credit. Whilst timescales are very challenging officers are confident that we can manage the situation.

6. A Healthier North Ayrshire/ A Safe and Secure North Ayrshire

Chief Inspector Tim Ross presented the Alcohol and Drugs Partnership Annual Report. This provides an overview of progress made over the past year using a template provided by the Scottish Government.

It was noted that many of the prescribed data sources only provide information from several years ago. There are therefore challenges in presenting a current picture.

It was agreed that a recent session run by the Alcohol and Drugs Partnership for Elected Members was useful in providing an overview of activity and that future sessions could be widened to include CPP Board members.

Tim Ross suggested that improved performance reporting could be developed by the Alcohol and Drugs Partnership and clearer illustrations of progress be presented to the Board in future.

The Board discussed the role of licensing on the consumption of alcohol amongst our local population.

The report was agreed by the Board.

7. Tackling Local Inequalities of Outcome

(a) Resource Mapping

Damien Griffith provided a report on Resource Mapping. An initial resource mapping exercise has been undertaken with further recent analysis on welfare benefit claimants across the neighbourhood areas. It was stated that further contextual information is required from CPP partners to assist in the interpretation of variance in gross expenditure across areas by their respective organisations.

The Board agreed to (a) note the need for further information, (b) note the rationale for the overall resource mapping exercise and its contribution to the transparency of future Neighbourhood Plans and (c) note the ongoing analysis of DWP benefits data and its potential application across the Partnership.

(b) Pre-Engagement and Consultation Programme

An update was provided by Damien Griffith on the second series of stakeholder and community based workshops on the Neighbourhood Approach during Winter 2014/15.

Workshops discussions with the three main stakeholders groups have taken place (Community Engagement Reference Group on 13/11/14, Community Planning Partnership Board on 18/11/14, and Elected Members on 20/11/14). Consultation with a wider group of stakeholders across the six neighbourhoods will take place in early 2015.

A number of themes were identified from these early discussions including the need to increase opportunities for coproduction with the Third Sector, improved communication, simplified language, engendering trust and a level of ownership of the process among all stakeholders. A full report of key findings from these and other workshops will be submitted to the March 2015 Board.

The Board discussed the challenges of using small area statistics in a consistent and meaningful way. Dr John O'Dowd, Consultant in Public Health Medicine advised of the development of a panAyrshire intelligence network to support this work.

The Board agreed the consultation programme.

8. Governance

(a) Audit Improvement Plan

Morna Rae presented a report on the CPP Audit Improvement Plan. Following the publication of the audit report in March 2013, an Improvement Plan was approved by the CPP Board in June 2013. There has been ongoing delivery and monitoring of the Improvement Plan. Audit Scotland undertook audit follow up in June/July 2014 and in their feedback letter they stated "It is clear that the CPP is taking action to address all of the areas in its improvement agenda". They also gave examples of specific areas of improvement which had been completed.

Updates were provided against each of the actions in the Improvement Plan. The Board agreed that good progress has been made across the themes. There are areas of work which will continue such as the delivery of the Neighbourhood Planning Approach but this does not require to continue to be monitored through the Improvement Plan as direct reports on progress are given to the CPP Board. It was therefore agreed that further Audit Improvement Plan progress reports are not required. A Development Plan for the CPP is being considered by the Strategic Management Team which will identify areas for development in 2015.

(b) CP Self Assessment

The Board considered a report by Morna Rae on CP Self Assessment. The Improvement Service have offered to support North Ayrshire CPP Board in a self assessment exercise. The aim of this would be to understand strengths and areas for improvement, to define challenges and to drive change forward.

At its meeting on 14th November the Strategic Management Team (SMT) considered whether North Ayrshire CPP should undertake this self assessment exercise and, if so, what the timing of this should be. The SMT's position was that participation should be delayed. Following the previous self assessment, audit, and SOA quality assurance processes we know what our areas for development are. We have fulfilled much of our previous Audit Improvement Plan and are developing our Development Plan for 2015.

There was discussion on the range of inspections and self assessment which has recently taken place across the partnership (e.g. Children's Services) and of the need to allow time for improvements to embed before further self assessment is undertaken.

The Board agreed the SMT's recommendation that participation in self assessment should be delayed, and that the SMT should consider the position in 6 months time.

(c) Benchmarking in CPPs

Morna Rae presented a report on a Scottish Government and Improvement Service benchmarking programme for Community Planning to support the ongoing reform of Community Planning and the delivery of improved outcomes. This will provide a framework which helps CPPs better assess their performance, evidence the impact of interventions, improve accountability/transparency, and share learning.

The CPP Benchmarking Indicator set will include a small number of high-level 'can-opening' outcome indicators to both inform CPPs' understanding of need locally and provide a basis through which CPPs can understand and ask questions about the impact of partners' interventions. The benchmarking framework will also highlight supplementary/drill down data in order to allow deeper exploration and better understanding of why areas differ.

The CPP Board noted the development of a CPP benchmarking framework and agreed to update reports in due course.

(d) SOA Action Plan 2014-15 Quarter 2 Performance Report

Community Justice Redesign

Morna Rae presented a report on proposals to implement a pan Ayrshire model for community justice services. The three chief executives of the Ayrshire local authorities and the Chief Executive of NHS Ayrshire and Arran agreed at the meeting of the Strategic Alliance of 7th November 2014 that one of the Ayrshire Community Planning Partnerships should take the lead for the strategic elements of Community Justice in Ayrshire. This would mean the re-branding the current SWSCJA as an Ayrshire Community Justice Strategy Group which is led by one of the Ayrshires and reports to all three Community Planning Partnerships. It is suggested some of the funding currently allocated to the South West Scotland CJA should continue to be made available by Scotlish Government to allow a rebranded sub-group for Community Justice to continue. This new structure would also cover the remit of the Criminal Justice Joint Committee. There will be consultation on how criminal justice services should be delivered and three options have been put forward as follows:

Option A – The Criminal Justice service would be delivered within each of the three Ayrshire Council areas (Lead Authority/local delivery model).

Option B - The Criminal Justice service would be managed by one of the Ayrshire Councils (Lead Authority/shared service model).

Option C - The Criminal Justice service would be managed and delivered within partnership teams aligned to Children and Family services with pan Ayrshire matters addressed through the single partnership.

The Board agreed the report.










Vehicle Fires: Accidental

Top 10 Accidental Vehicle Fire Locations














False Alarms: Good Intent







Purpose:	To provide the Committee with information relating to social housing development opportunities in the North Coast Sub Housing Market Area.
Recommendation:	It is recommended that the Committee notes the content of this report.

1. Introduction

- 1.1 The North Coast Sub Housing Market Area comprises of Largs, Fairlie, West Kilbride and Seamill, Skelmorlie and the Isle of Cumbrae.
- 1.2 In 2009, Housing and Planning Services jointly commissioned a North Ayrshire Mainland Housing Needs and Demand Assessment (HNDA). As part of a cohesive and inclusive strategic framework, the findings of this assessment informed firstly the Main Issues Report, followed by the Local Housing Strategy, and finally the Local Development Plan.
- 1.3 The mainland HNDA was accredited by the Scottish Government as 'robust and credible'. It found that the mainland North Coast Sub Housing Market Area (SHMA) has the highest affordable housing shortfall in North Ayrshire. The shortfall is concentrated in the town of Largs.
- 1.4 As a result, the Local Housing Strategy (LHS) 2011-2016 recognises the town of Largs as having the greatest need for affordable housing investment within North Ayrshire and the remaining mainland North Coast Sub Housing Market area as having the third highest need for investment.

2. Current Position

- 2.1 As part of the LHS process, the Council is required to prepare a Strategic Housing Investment Plan (SHIP) which is submitted to the Scottish Government every two years. This plan sets out the current investment priorities and forward affordable housing development programme.
- 2.2 Since the LHS was adopted, additional and ongoing research has

- indicated that there is almost no affordable housing demand pressure in Skelmorlie or on Cumbrae.
- 2.3 The North Coast (excluding Cumbrae and Skelmorlie) has had the highest recognised priority for affordable housing policy interventions since 2009.

Local Development Plan

- 2.4 A key constraint to developing in Largs is the lack of available land. The geography of the town (ie. surrounded by sea or hills) makes it difficult to expand the existing boundaries.
- 2.5 This in turn pushes up the value of available land, making it expensive, and therefore not suitable for social housing development.
- 2.6 In recognition of these constraints the Local Development Plan (LDP), which was adopted by Council on 28 May 2014, sought to increase affordable housing numbers by allocating mainland North Coast sites specifically for affordable housing development purposes.
- 2.7 This means that land values on these sites do not increase as a result of the residential planning allocation, as the only use they have is for affordable housing development.
- 2.8 All sites allocated for affordable residential development have been included in the development programme, with the exception of Alexander Avenue, Largs.
- 2.9 Consultation is currently being undertaken in relation to a new education campus for Largs, which would occupy the land currently allocated for affordable housing adjacent to Alexander Avenue.
- 2.10 If development of the new campus goes ahead then the future uses of the existing school sites could include affordable housing.
- 2.11 The LDP introduced the mainland Affordable Housing Policy. This policy notes that market development in the entire North Coast SHMA will be subject to a developer contribution at a rate of 25%. This is the highest contribution rate in North Ayrshire.
- 2.12 All contributions should have an identical financial impact on the developer and all are calculated by assessing 25% of the difference between the market and affordable value of the site.

- 2.13 In practice, this means that when a private developer seeks planning permission, they will be asked to factor in either:
 - the transfer of 25% of the complete units on site to the Council or local RSL:
 - the transfer of 25% of the developable land on site to the Council or local RSL; or
 - pay a commuted sum.
- 2.14 The LDP identifies sufficient market sites in the North Coast to allow approximately 400 units of market housing to be delivered. As per the terms of the Affordable Housing Policy, outlined above, this could provide up to 100 additional units or equivalent contribution for the North Coast.
- 2.15 Any sites which are not specifically allocated within LDP, but which are suitable for residential use, will be subject to the same 25% affordable housing contribution.

Affordable Development Programme

2.16 The affordable development programme for the North Coast area for the period 2011-2020 is as follows:

- 2.17 By the end of 2016, 74 new units of affordable housing will have been built during the lifetime of the Local Housing Strategy 2011-2016 in mainland North Coast (excluding Skelmorlie), 49 of which are in Largs.
- 2.18 The Council continues to seek development opportunities in both Largs and the wider mainland North Coast (excluding Skelmorlie).
- 2.19 The Council is also introducing other investment programmes which have the potential to impact on the North Coast. This includes buying back 8 properties which have been offered to the market, and which were previously subject to right to buy.
- 2.20 This affords the Council the opportunity to address small pockets of housing pressure or to target particular housing types.

Pressured Area Status

- 2.21 Housing Services has also sought to protect the existing social housing in the North Coast area. On 26 March 2014, Cabinet approved a report which sought permission to designate various areas in North Ayrshire, including the entire North Coast SHMA, as pressured. This designation suspended the right to buy for many tenants in the North Coast area, for a period of 10 years.
- 2.22 Pressured Area Status is due to be superseded by legislation which has just been passed which will end the right to buy for all tenants from summer 2016.

3. Proposals

3.1 It is proposed that the Committee notes the content of this report.

4. Implications

- 5.2 Consultation with key stakeholders was a key element of the HNDA preparation. The Main Issues Reports, Local Housing Strategy and Local Development Plan were subject to extensive consultation with all relevant parties, including public consultation.

6. Conclusion

- 6.1 This reports details the opportunities for social housing development in the town of Largs, and wider North Coast Area.
- 6.2 Housing & Planning Services continue to adopt a strategic approach to addressing housing need, and involve partners and stakeholders in the ongoing endeavours.

12. How will the expenditure develop the group/organisation and benefit the local community?

The expenditure is to support the costs of the club hosting its 50th Anniversary Celebrations in 2015 - it was founded in 1965.

It is important for the identity of a community that its organisations, identity and culture are celebrated - and reaching this milestone is important for the club and Largs as a whole.

It is keen as part of its 50th year activities to engage more with local schools - and to this end discussions have started with Active Schools. This is part of their plan to change the age profile of the club overall.

13. How does the application show innovation or development?

Douglas Park is the only Bowling Club in the North Shore which provided walk on playing facilities for non-members and visitors. This is part of the lease agreement with North Ayrshire Council - the club lease the clubhouse from the Council and also pay for maintenance of the green (the Council's Streetscene Section maintains the ornamental and woodland areas of Douglas Park, and the Burns Garden).

The club has recently made successful funding applications to the Largs Common Good Fund and the Kelburn Wind Farm Community Fund. These have helped upgrade the clubhouse, and also improve changing facilities for visiting clubs. In recent years the club has also upgraded its kitchen and bar areas.

The success of Scottish Bowling at the Glasgow Commonwealth Games has generated new interest in the sport, and Douglas Park Bowling Club is keen to make the most of this by increasing the number of young players at the club. Furthermore, it has good access for those with impaired mobility which may be a consideration when Inverclyde becomes the Scottish Centre for Disability Sport.

14. Overall assessment?

Douglas Park Bowling Club likes to think of itself as the 'friendly club', and is open to new ideas whilst upholding its heritage.

It is one of 3 Bowling Clubs in Largs and currently has 56 members.

1. Introduction

- 1.1 North Ayrshire Council previously approved the establishment of Charitable Trusts at its meeting in January 2012. A subsequent report was submitted to the Committee outlining the proposed procedure for considering applications and grants from the Trust. The Committee agreed to delegate the administration of the Largs Trust, including disbursements from the Trust, to the North Coast Area Committee.
- 1.2 In the case of the Largs Trust funds are held for the purpose of:
 - A the prevention or relief of poverty;
 - B the provision of recreational facilities, or the organisation of recreational activities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended; and
 - C the relief of those in need by reason of age, ill-health, disability, financial hardship or other disadvantage.
- 1.3 The Executive Director (Finance and Corporate Support) confirmed to the Council on 2 April 2014 that the amount available for disbursement from the Large Charitable Trust for 2014/15 is £329.

2. Current Position

- 2.1 The Trustees' primary obligation is to consider whether an application meets the trust purposes in accordance with the terms of the Trust Deed. In so doing, the Trustees must act in good faith. Largs Community Sports and Leisure Club received £2,000 from the Community Development Grant Scheme Award in 2013/14 for the same purpose.

To continue to subsidise this type of group for the same purpose to attract more primary school children, parents etc. offering both outside and inside taster sessions will set precedence for the future.

This is an extract from the assessment: The Club has recently carried out an extensive consultation exercise which was carried out by Largs Academy pupils and included the 6 local Primary Schools (Staff, parents and pupils), Social Services, and Enable Scotland (the Club has provided support for young people affected by disability through the partnership with Active Schools). This has led to an expansion of the programme, opening hours, and days in which the Club operates.

The Income from the club members pays for the coaching costs. Coaching is predominantly delivered by young leaders from the Active Schools programme. Activities currently on offer include gymnastics, basketball, badminton, football, dance, boxercise, cricket, rounders, and table tennis. The

 Club meets on Saturday mornings in Largs Academy.
