- reasons behind the lower detection rate for crimes in the Irvine East ward in December 2015 in comparison to December 2014.

I have reviewed the application for £44,512.67 plus an agreement to underwrite any additional costs to the value of £10,000.00 if required - the costs supplied are based on a grant of £44,512.67 and there are no objections to this. There are no costs detailed for any additional spend that the Marymass Festival may incur, therefore I am unable to give any comment on the request for additional £10,0000 if required.

The Marymass Festival has already received a grant this financial year, 2015/16, for £48,994.10, therefore the amount currently available for disbursement is £3,111.

If the grant is awarded it is recommended that it is paid after the 31st March from the budget for 2016/17 which has been agreed at £61,710.00.

1.1 At a previous meeting of the Irvine Area Committee is was agreed to award Irvine Winton Bowling Club £1,800 towards refurbishment costs to the club subject to the club confirming in writing that they would be in a position to fund the balance of the project.

- 2.1 A Senior Manager visited the group to make sure that the club could raise the sufficient balance to enable the release of an award.
- 2.2 The club requested a change to the award towards the statutory requirement for disabled access to the club and was advised that it would have to come back to the Area Committee for consideration.
