The Liaison Meeting received a presentation on the work of Fullarton Community Health House which was established in September 1989 and provides a number of services to the residents of the Fullarton area of Irvine and beyond.

The Health House is currently involved in a number of projects:-

Fullarton Health and Safety Project

To bring greater understanding of health and safety issues to the public.

MAN (Men's Action Network)

To encourage men to make health choices for themselves and employ a holistic view of health.

• The Community Involvement Project

To increase the self-esteem and confidence of people allowing them to become more fulfilled individuals.

Domestic Violence Project

To encourage individuals who perpetrate domestic violence to accept responsibility for their actions and change their behaviour.

Voluntary Option of New Deal

An approved centre for SVQ Level II Business Administration and SVQ II Using Information Technology.

Motive8

To provide intense client focused activity by working with individuals to achieve, establish and foster growth.

Working for Families

A project specifically aimed at the Working for Families target group.

3. Health Service Developments

Submitted report by the Operational and Performance Improvement Manager, North Ayrshire Community Health Partnership, on new and emerging service developments affecting North Ayrshire.

NHS Ayrshire and Arran has an extensive modernisation programme comprising a combination of third party development schemes, capital programme schemes, or submissions made to ring fence monies such as the Primary and Community Care Premises Modernisation Programme. The Community Health Partnership are charged with ensuring that estates and facilities are developed to best meet the needs of the population.

The following information was provided in relation to facilities within the Committee's area:-

Eglinton Street General Medical

Practice, Irvine

Originally temporarily housed in Ayrshire Central Hospital with a view to remaining on site as part of the overall development of this site. A schedule of accommodation has been developed and a draft brief prepared.

Montgomerie Park, Irvine The Montgomerie Park development will

provide a replacement satellite surgery for the existing Frew Terrace practice which will cease to operate out of Lanfine Way.

Kilwinning Both Kilwinning practices have been

approached to explore rationalisation of

services in Kilwinning. The Oxenward practice

does not plan to move from its existing premises. The Medical Group practice is exploring integration with community services

at the Fergushill Clinic.

Townhead, Irvine Preliminary discussions have been held with a

view to a third party developer scheme

solution at this location.

Ayrshire Central Hospital, Irvine A Feasibility study is underway. Two groups

have been established to consider clinical and non clinical implications and opportunities at

this site.

The Liaison Meeting discussed the lack of practice facilities within the village of Springside.
