# Possible Industrial Action - Caledonian MacBrayne Limited

Councillor Sillars reported on the possibility of industrial action being taken by employees of Caledonian MacBrayne Ltd and the effects which such action may have on the islands of Arran and Cumbrae. Similar industrial action in the past had led to economic hardship for the residents of both islands. Councillor Hill expressed similar comments.

The Council agreed to write to the Secretary of State for Scotland on the likely effects of such industrial action and requesting that he take steps to resolve any possible dispute.
