1. Declarations of Interest

In terms of Standing Order 10 and Section 5 of the Code of Conduct for Councillors, Councillor Gallagher, as Chair of the Viking Festival, declared an indirect pecuniary interest in the group's funding application which formed part of Agenda Item 9 (Community Development Grant Scheme and Local Youth Action Fund -Applications for Financial Assistance), vacated the chair for this item of business and took no part in its determination.

Councillor Hill, as a member of Fairlie Gala Committee, declared an indirect pecuniary interest in the group's funding application considered as part of Agenda Item 9 (Community Development Grant Scheme and Local Youth Action Fund - Applications for Financial Assistance).

Councillor Marshall, as a member of the congregation of St. John's Church of Scotland, Largs, declared an indirect pecuniary interest in the group's funding application, which formed part of Agenda Item 13.1 (Largs Common Good Fund: Application for Financial Assistance), and took no part in its determination.

2. Minutes

The accuracy of the Minutes of the ordinary Meeting of the Committee held on 21 May and the Special Meetings of the Committee held on 18 June and 25 2015 was confirmed and the Minutes signed in accordance with Paragraph 7 (1) of Schedule 7 of the Local Government (Scotland) Act 1973.

3.1 North Ayrshire Community Planning Partnership (CPP) Board: Minutes of Meeting held on 11 June 2015

3.2 Police Scotland

Inspector Joseph Conway provided a verbal update on issues of local interest for the current financial year to date, including information on the following:-

- crime statistics for the North Coast area, including a drop in overall reported crime compared with the same period last year;
- three serious assaults since the last Area Committee meeting, all of which have now resulted in arrests; and
- policing at recent events, such as Largs Live and the Kelburn Park Garden Party, and plans to provide policing support at the forthcoming Viking Festival.

Members discussed the following:-

- changes to the statistical reporting of crimes and the continued ability to track trends;
- an incident of domestic abuse in the Waterside Street area of Largs; and
- domestic abuse reporting arrangements more generally.

Noted.

3.3 Scottish Fire and Rescue Service

Submitted report by the Scottish Fire and Rescue Service on incidents within the North Coast area during the period 11 May to 29 July 2015.

The report included information on the following:-

- 5 accidental dwelling fires and one accidental non-domestic fire in Largs;
- 3 heath and grass fires within Largs and Fairlie;
- a number of good intent and equipment fault false alarms, mainly in Largs and Cumbrae;
- three road traffic collision incidents; and
- special services events in Largs.

Members discussed the Fire and Rescue Service's role in assisting paramedics to gain entry to premises.

Noted.

4. Roads Maintenance Programme 2015/16

Submitted report by the Executive Director (Place) on the Structural Roads and Street Lighting Maintenance Programme for 2015/16. The report set out the approach taken to determining the asset maintenance programme for roads and street lighting and highlighted at Appendices 3a and 3b the 2015/16 maintenance programme.

The Assistant Network Manager also reported verbally on road works to the A760 at the Haylie Brae 2015, planned for September 2015.

Members discussed the following:-

- confirmation that the planned Haylie Brae road works would not impact on traffic movement during the September holiday weekends; and
- factors influencing the lifespan of the road surface on the A760.

Noted.

5. Largs Reports

5.1 Largs Campus

The Committee received a presentation by the Project Manager (Place) on progress in respect of the Largs Campus development, which included a video animation on the consultation process.

The presentation highlighted the following:-

- the consultation arrangements and the next stages;
- feedback from individual schools on the proposals;
- the initial concept design;
- the forthcoming pre-planning consultation exercise; and
- the next stage in terms of the detailed design of the campus.

Members discussed the following:-

- the design principles associated with Curriculum for Excellence;
- the extent to which the views of staff will be taken into account when considering the detailed internal design of the campus; and
- the need, due to the exposed nature of the site, to put in place design measures to avoid wind damage to the exterior of the campus or the formation of wind tunnels.

Noted.

5.2 Largs Sea Front Car Park: Update on Projects and Car Park Usage

Submitted report by the Executive Director (Place) on the implementation of agreed projects and the usage of the Largs Sea Front Car Park between April and June 2015.

The report included information on the following:-

- plans to consider improvements to town centre paving as part of the Largs Masterplan;
- the installation by Transport Scotland of new lighting columns;
- the Largs masterplanning exercise, including the outline proposals which were subject to public consultation in January 2015;
- the completion of works to replace two decorative stones on the Pencil Monument;
- improvements to the Haylie Brae picnic area;
- progress in respect of the 'quick win' improvements identified by the Area Committee;
- an analysis of Sea Front Car Park usage; and
- current budget position of the Car Park Fund, which has a balance of £310,728 available in 2015/16 to fund the Viking Project and any new projects.

A verbal update was also provided on the current cost of erecting this year's Viking Festival village, namely £29,407.93.

Members discussed the following:-

- the need for clarification in respect of the presentation of budget expenditure information;
- the status of the masterplanning exercise;
- the accuracy of the information on car park usage; and
- the cost of erecting the Viking Festival village each year and the possibility of either reducing this cost or directing expenditure to a more permanent structure.

Thereafter, the Committee received a presentation by the Streetscene Officer (Place) on issues which would require to be taken into account in terms of a suggested windflower meadow on ground adjacent to the Haylie Brae, including site preparation works, appropriate plant varieties, sowing options and maintenance.

Members the discussed the following:-

- whether any kind of planting proposals would be feasible;
- alternative options for making this area of ground more attractive; and
- a request from a local supermarket to review the charges at the Sea Front Car Park for short, one-hour stays.

The Committee agreed (a) that the Streetscene Officer submit a report to the next meeting on (i) a detailed breakdown of the costs associated with erecting the Viking Festival village, to allow Members to assess if the costs might be reduced and whether to consider alternatives to erecting the village on a year on year basis, (ii) on alternative proposals for introducing a 'gateway to Largs' feature on ground at the Haylie Brae, Largs, following discussion with the Countryside Manager and colleagues within Roads and (iii) the likely financial implications of introducing a reduced parking charge for one-hour stays at Largs Sea Front Car Park; (b) that the Acting Committee Services Manager establish whether the TGP report on the Largs Masterplan is available for circulation to local Members; and (c) otherwise, to note the information provided.

5.3 Targeted Assessment of Property Condition in Largs

Submitted report by the Executive Director (Place) on a pilot 'targeted assessment' of private sector housing stock in Largs. This matter arose from a request by the Area Committee to assess the standard of private housing in the Largs area.

The targeted inspection comprised 41 properties dispersed between 7 blocks, at 97-109 Nelson Street, Largs. Section 2.14 of the report summarised the findings of the pilot exercise, including the identification of one property as falling below the tolerable standard, as well as the number of empty homes. The Private Sector Advice Team has now carried out a 'match-making' exercise, where owners of empty homes who wish to sell agree for their contact details to be passed to other property owners in the area, and this has resulted in one of the empty properties in the pilot area being purchased. The team has also been successful in securing agreement from the majority of owners in two of the three blocks which are experiencing water ingress to attend maintenance plan meetings convened by the Council.

Members discussed the following:-

- other options for securing improvements to properties, including through compulsory purchase;
- the Council Tax applicable to empty homes; and
- the potential for working with other agencies to improve properties.

The Committee agreed (a) that the Divisional Manager (Housing) (i) investigate the available options, including compulsory purchase and work with other agencies, for effecting an improvement in the quality of housing stock available in the area identified within the targeted assessment and (ii) submit a report on the matter to the next meeting; and (b) otherwise, to note the content of the report.

5.4 Economy and Communities Update

Submitted report by the Executive Director (Economy and Communities) on actions taken in relation to a number of projects and issues in the Largs area.

The report included information on the following:-

- thew Largs Forestry proposals, which are still with the Forestry Commission for consideration;
- preparatory work in connection with Largs Viking Festival;

The Committee was invited to consider whether it would wish to seek the return of the additional grant funding, or agree a further award to the group to regularise the matter.

The Committee agreed to approve the award of a further £2,500 to St. John's Church in respect of its earlier Largs Common Good application.

Subject: Largs Sea Front Car Park: Implications of Introducing a Reduced Parking Charge for One-Hour Stays

Purpose: To provide the Area Committee with the possible financial implications of introducing a reduced parking charge of £1.00 for stays of up to one hour and £3.00 thereafter.

Recommendation: That the Committee notes the possible financial implications of altering the parking charges at Largs sea front car park.

1. Introduction

1.1 At its meeting on 13 August 2015, the Committee requested information regarding the likely implications of introducing a reduced parking charge of £1.00 for one hour stays at Largs Sea Front Car Park.

2. Current Position

- 2.1 Currently the fee for using the Largs sea front car park is £3.00 per stay per day, regardless of duration.
- 2.2 Data collection for occupancy levels for the car park began in May 2014 and show that, from May 2014 to March 2015 inclusive, revenue was at £193,110. Modelling of the usage information for the period has shown that, had there had been a dual charge of £1 for one hour stays and £3 thereafter, the total income generated would have been £167,144, i.e. a reduction of £25,966.
- 2.3 The first quarter of 2015/16 shows a total revenue of £72,957 with a flat £3 fee, as opposed to £62,715 if a dual fee had been in force, i.e. a reduction of £10,242.
- 2.4 The above information is based on the known number of vehicles entering the car park over the fourteen month period. Reducing the charge for shorter stays may increase usage by visitors and residents who currently choose to park in the streets near the seafront. It should be noted that the usage of the car park can vary depending on factors such as weather, events etc.

- 2.5 Appendix 1 summarises the comparison in income generated from the two charging policies between May 2014 June 2015.
- 2.6 The Committee is asked to note that any reduction in income generated from the car park will have an impact on the level of projects that are able to be undertaken from the Car Park Fund. Should the Committee wish to consider altering the charging arrangements, it is recommended that this is initially done over a pilot period to enable an assessment to be made on the impact on usage levels and associated revenue.

Subject: Place Update - Largs

Purpose: To provide the Area Committee with (a) an update on associated costs with the building and dismantling of the Viking Festival Village for 2015; and (b) an update on Largs Campus.

Recommendation: That the Committee notes the content of the report.

1. Introduction

1.1 In March 2015, the Chair of the North Coast Area Committee requested regular updates on a list of projects and issues pertinent to the North Coast area.

2. Current Position

2.1 Updates are provided on projects/issues of interest to the Area Committee as follows:

Costs Associated with Building the Viking Festival Village

- 2.1 The Viking Festival Village is built annually by North Ayrshire Council's Streetscene Team; this includes the huts and boundary fencing. The team cuts and affixes conifer vegetation for 'dressing' the roofs of the huts, transports materials such as straw, wood, chairs, planted flower troughs, fire extinguishers and other incidentals to the Viking Village and prepares & lights the Beacon.
- 2.2 The huts, hurdles, fencing and other incidentals are stored in three shipping containers at the Council's Largs Depot at no cost to the Viking Festival.
- 2.3 The building of the Viking Festival Village commences approximately two weeks before the start of the Viking Festival and it is later dismantled within a week of the Viking Festival ending.
- 2.4 The majority of the build of the Viking Village is done out-with core hours as the Streetscene Team has its day to day duties to fulfil. The costs for labour and materials for the 2015 event is £30,132.03 (see appendix 1).

- 2.5 Due to 'wear & tear' and building and dismantling the Viking Village structures annually, the three small huts will need replacing for 2016, at an indicative cost of £1,500 each. Replacement hurdles will also be needed at a cost of £3,659.54 (at 2015 prices), plus servicing of fire extinguishers at an estimated cost of £600 (dependent on condition).
- 2.6 If the Viking Village was to become a more permanent year round feature outdoors, the huts etc. would need to be constructed of suitable weatherproof materials.

Largs Campus

- 2.7 Pre-planning consultation events were held on 24 and 26 August 2015, attended by over 150 people.
- 2.8 The project team will review consultation feedback and respond to priorities raised within the pre-planning consultation.
- 2.9 Engagement with staff, pupils and parents will be continued, to support the development of the internal and external layouts of the Campus facilities.
- 2.10 The archeological survey has uncovered pits/structures close to the proposed PE facilities which will require further investigation.
- 2.11 It is anticipated that the full planning application will be submitted at the end of September 2015.

Subject:	Largs Masterplan
Purpose:	To provide members with an update on the Largs Masterplan.
Recommendation:	That the Committee notes the production of the draft Masterplan.

1. Introduction

- 1.1 North Ayrshire Council is committed to supporting the development of our towns and in particular their town centres. Support for town centres forms a key part of the regeneration outcomes contained within the Economic Development and Regeneration Strategy and the 2015 Economy and Communities Service Plan.
- 1.2 This report follows on from a meeting held between North Coast Area members and NAC officers held on 8 May 2014, during which members agreed to progress work in support of a Masterplan approach to regeneration opportunities in Largs. The Masterplan was also endorsed by the Cabinet of North Ayrshire Council on 15 September 2015, subject to future funding options being identified.
- 1.3 This report provides an update on the Largs Masterplan report.

2. Current Position

Background

- 2.1 In May 2014, following a meeting between the Largs BID Executive Group, North Ayrshire Council officers and North Coast Area members, it was agreed to commission a Masterplan with recommendations and costs for the implementation of physical regeneration projects between the railway station, main street and Vikingar and onto Aubrey Park. The study area also extended as far as the play park adjacent to Charles Street.
- 2.3 The Tenant Garmory Partnership (TGP) were subsequently appointed to advance the Masterplan. Specific tasks included identifying key projects, developing initial design proposals, alongside ensuring stakeholder involvement and buy in.

- 2.4 The Masterplan (attached as Appendix A) provides outline proposals for enhancement and improvements to the town centre and promenade, reinforces connections within the town, the sea and to other facilities and initiatives, provides and defines hierarchy, linkages and attractions and reinforces the character of the town. Further design development would be required to realise full improvement proposals and cost estimates. The Masterplan has been separated into priority areas. The four key areas for consideration include:
 - Aubery Park;
 - The Seafront/Promenade;
 - Main Street and the Ferry Terminal; and
 - Gallowgate Square.
- 2.5 Indicate investment requirements are presented within the report on a priority basis, subject to approval the Masterplan will inform and guide both the spend of existing budgets and future commercial and public investment. It should be noted that the Cabinet of North Ayrshire Council as part of their endorsement of the Masterplan, approved the progression of proposals in support of Gallowgate Square during 2015/16.

3. Proposals

- 3.1 It is proposed that the Area Committee:
 - 1) Notes completion of the Masterplan;
 - 2) Provides comment on the appropriateness of the proposals;
 - 3) Endorses the Largs Masterplan; and
 - 4) Note the intent to progress Gallowgate Square during 2015/16, following on from Cabinet approval.

4. Implications

Financial Implications

4.1 The Masterplan provided indicative capital requirements for each of the phases of development set out in the document. It is proposed that one of the priority projects, Gallowgate Square is implemented as a first phase from existing resources within the Town Centre Regeneration capital budget. Funding of additional projects would be the subject of future reports to Cabinet and Area Committee, as appropriate.

4.5 All design work will be advanced in line with best practice environmental sustainability guidelines.

4.6 The on-going development of Largs will advance town centre priorities contained within the Economic Development and Regeneration strategy and the Economy and Communities Operational Plan, specifically around 'growing our economy, increasing employment and regenerating towns'.

5. Consultations

- 5.1 Throughout the Masterplan exercise, TGP consulted with:
 - North Coast Area Members;
 - North Ayrshire Council officers;
 - Staff from Largs Bid; and
 - Members of the Largs Community via drop in sessions.

6. Conclusion

6.1 The Largs Masterplan will be used to inform the development of the town, tourism and maritime priorities and other capital investments as and when funding opportunities are identified.

6.2 It is recommended that the North Coast Area Committee note the content of this report, endorse the Masterplan and support proposals for the refurbishment of Gallowgate Square during 2015/16.



1 Introduction

TGP were employed in August 2014 by North Ayrshire Council to prepare a masterplan with recommendations and costs for priority projects for the town centre and seafront of Largs. The following report covers an outline of the consultation process and the reasoning for the design decisions made, priority projects and phased masterpan.

The clients brief stated that 'Well defined areas within Largs Town Centre are essential to creating positive impressions of this bustling seaside town. Landscape interventions should seek to reinforce the quality and stature of the intended study area, encouraging movement, access and a sense of place, whilst building upon the success of Largs as an attractive location and environment and ensure the on-going perception of Largs as an important destination within the portfolio of North Ayrshire towns'.

The brief included a study area which covers Main Street. Aubery Park, the Promenade and Charles Street, this was extended as part of the study process to include the Promenade and grass area to the south of the play park adjacent to Broomfield Place and Crescent .

The brief also included the following requirements :-

- enhancing the arrival in Largs and movement through the town;
- reinforcing the connection between the waterfront, Promenade and Vikingar with the main street and railway station;
- considering options for Aubery Park, that would create a significant destination draw for Largs;
- considering the relationship between the Promenade and the parkland adjacent to Charles Street;
- enriching the public realm and defining a clear hierarchy and linkages. Particular consideration should be given to the relationships between pavements, roads and open space;
- creating/renewing landmarks for identity and navigation; and
- re-enforcing the individual character of the area as a distinct and important part of the overall town.

One element of the study was to ensure stakeholder involvement and buy in. TGP worked closely with Council Officers, Councillors and the Largs Bid Team to ensure all issues regarding the town and seafront were considered for proposed physical improvements and the essential aspects of the brief were adhered to in our design considerations. There was also a public exhibition where locals and residents were consulted on their ideas and preferences. Once information had been gathered through the survey and consultation process, a masterplan was produced and costs were prepared. The Coastal Design Guidance and the Town Centre Design Guidance publications by Anderson Bell Christie for Irvine Bay Regeneration and North Ayrshire council were useful reference during the masterplanning process.

The masterplan and costs estimates will be used to apply for funding and inform future design development.

2 Site survey and appraisal

Initial thoughts and response to the brief and site survey included:-

- The history of the town and its use as a major seaside / holiday destination is important. Consider ways of creating an 'atmosphere' and 'character' to the landscape design. This can be done through careful use and design including artworks, surfacing, street furniture and boundary treatment.
- The ferry terminal and transport links to Great Cumbrae from Glasgow and elsewhere. These require a cohesive and attractive arrival and departure point and obvious 'leads' into the town are required. This includes the train station, the main A78 through the town from both north and south and the area around the ferry and the pier.
- Buildings and places of significance. Highlight and reflect on these in the masterplan. Consider matching materials, interpretation etc.
- State of deterioration. The existing promenade pavement and furniture is in dire need of replacing. There is a great opportunity to provide design solutions which use contemporary materials and furniture.
- Bedding displays. There are a number of displays along the seafront which are well kept and maintained. It is a tradition of seaside towns to have these displays and there should be a place for them, perhaps a more contemporary approach is required.
- Aubery Park and boating pond. Formally Noddsdale Green, developed in the late 50's or 60's, it is the 'full stop' at the northern end of the promenade. The park is in a state of disrepair with the pond leaking and the facilities lacking. To attract visitors to walk the length of the promenade and visit this park, a completely new approach to the park design and an attraction or 'draw' is required.
- Vikingar. The Leisure Centre and the area to the front of the building is well kept and used as a pitch and putt course.
- Charles St Park, play park and memorial. The memorial park hasn't changed greatly over many years, there are areas of bedding around the monument. The paving and certain landscape features are in a state of disrepair. The coloured seating is fun and memorial seats have a place, but is it sustainable and how can it be improved? The play park is a 'full stop' at the southern end of the promenade, there is a big change in level between the road and the play area which in the past was connected by terraces. The study area should be extended to include Broomfield Place and Crescent as the there is potential for to use the grass area and extend the improvements along the seafront.
- The commercial aspects of the water front 'Nardinis', restaurants, games zones, road front, shops, car parking. These all need to be considered in relation to the physical aspects of the proposed improvements and include access and servicing.
- Bringing into the 21st Century. We reviewed some historic photos of Largs and realised ٠ that little had changed over the past 100 years. The new proposals need to provide unique ideas which allow for sympathetic contemporary design which will be practical

but fun and will also be suitable for the council's maintenance regimes. This would include Gallowgate Square which is well used but out dated and spoilt by the location of refuse bins.


- Weather and coastal conditions. The extreme coastal conditions can cause damage to surfaces, features and furniture. Materials and design will need to ensure suitability to the situation.
- Disconnection with the sea. How can the design proposals make use of and celebrate the sea . front?
- The need to provide suitable areas for temporary festivals and events. There are a number of annual events and festivals occuring in Largs which would benefit from better facilities such as hook ups, hard standing etc.
- Car parking. During the Summer months car parking seems to be an issue and in the winter the on the Main Street are misused.







3 Strategic plans and priorities

As a result of site appraisal and with consideration to stakeholder consultations, themes and ideas were distilled to form 'Initial Ideas and Priorities'.

Criteria set for prioritising the most desirable projects :-

- Improvements most in demand by stakeholders
- Easy projects to implement
- Cheaper projects to implement
- Projects which will attract duel funding
- Long term, less necessary projects





) Town Centre public realm improvements

It became clear as a result of the consultations that the Town Centre was the area highest priority for improvements as it would have the biggest impact.

This was due to a number of reasons including:-

- The first impressions of the town, either by arriving on public transport (ferry, rail) or in a vehicle
- The need to reinforce links and connections with the rest of the town
- Enriching the public realm and improving the user experience
- Creating more room and less confusion for the walking public by removing parked traffic and providing wider pavements thus reducing the risk of traffic accidents and undo congestion at the ferry terminal

However, complications relating to the ownership and management agreements with Transport Scotland who manage the Trunk Road network could limit what is achievable in relation to materials and road alterations in the town. Also discussions with Caledonian Macbrayne on the possible increased queuing requirements in Fort St. could make it a longer term project. The Gallowgate Square which is centrally located in the town and owned by North Ayrshire Council has been included as a high priority project as this would be relatively cost effective and simple to implement, it can be used by town's people and visitors alike for seating but also for temporary events and farmers markets etc. Simple redesign to allow more flexibility should be considered.




2) Aubery Park redesign

'The Game Changer' and the 'draw' to the town. The concept being the total redesign of the park, creating an innovative new recreation space and iconic feature but including some of the traditional uses of the park. The idea being that visitors would be attracted to Largs by an iconic visitor attraction which could be marketed and promoted as such, but also upon arriving at Largs the improvements to the park and the iconic feature could be seen from a distance, encouraging visitors to walk along the promenade and spend more time in the town. This would be expected to be a longer term and relatively high cost capital project.

Precedents along a similar theme would include:-

- 'The Helix' in Falkirk where a new park has been created and the Kelpies
- The Comedy Carpet in Blackpool
- Redcar's Viewing Beacon, built as part of the seafront improvement scheme.



3 Seafront / Promenade redesign

The Promenade is a relatively easy fix as the majority of it is owned by North Ayrshire Council, improvements are simple and relatively easy to implement, although it is not top priority amongst stakeholders due to the fact that it exists and that it is usable / functional at present. It would however be a big attraction and would encourage visitors to stay in Largs and walk along the length of the seafront and connect with the improved Aubery Park, town and the sea.







4 Promenade south of Ferry terminal, Charles St Recreation Ground

This area has attractive facilities that are well used. Any improvements would be minor and not have the same impact as those to the north of the ferry terminal. This part of the Promenade should be designed using consistent materials and design features as the area to the north.

5 Broomfield Place / Crescent, grassed area to south

This area does not seem to be a high priority to the people of Largs. However it has potential to become an attraction in its own right. Given that this is where the only sandy beach is located in the town and where sea and climatic conditions are more favourable for water sports, it would benefit from improved facilities and access to the shore. The Clyde Coastal Rowing Club are proposing to locate and build a boat storage facility in this area.

Ongoing Local initiatives include :

Clyde Coastal Rowing Club – Proposed workshop and boat storage facility Largs Community Council – Proposed Heritage Trail and Interpretation Largs Community Council – Proposed external gym equipment along promenade



Main Street and Tron Place - Ranking Priority 1

The Main St., Tron Place and Largs Railway Station Entrance will be upgraded to provide a welcoming arrival to the town not only for pedestrians but for vehicular and train passengers. 




The design concept is to create a smart new promenade with updated and functional street furniture, a newly surfaced path and protection from the sea. The incidental plazas and shelters/ kiosks along the way are situated at intersections suitable for crossing to the town and providing functional spaces for activity and shelter but also allow access to the beach and sea. These attractions located along the promenade will encourage people to venture further and stay longer.


5 Recommendations


Aubery Park – To create a high profile and national awareness the design proposals could be formulated through design competition. This would provide a platform for the best design ideas and interest from Design Professionals but also stimulate an interest in improving the whole of Largs Town Centre and its Seafront.

The Seafront / Promenade – The hard surfaced area of the Promenade is ripe for improvement and updating. The 'Car Park' fund could help to generate funds for this relatively simple design and implementation. A multidisciplinary design team lead by a landscape architect could develop the design for the Promenade. Whilst it would be best to implement this in one, the works could be divided into sections and certain aspects work could be carried out incrementally if total funds were not available. It is likely that trials and boreholes would be required to check the make up of the existing promenade and any problems with erosion. The flood defence walls should also checked for structural stability.

Main St. and The Ferry Terminal – Discussions between Transport Scotland and NAC Roads Department would be required in the first instance. A landscape lead design team could develop the urban realm proposals. Further discussions will be required with the owner of the Amusement arcade as this section of the Promenade is in their ownership. Caledonian Macbrayne will also require to be consulted. Information on underground services and public utilities should be forthcoming before further design development takes place.

Gallowgate Square – is a simple one off design for a refurbished amenity space and its design development could be taken forward by a landscape lead team. This could be a stand alone project.







Appendix 1: Stakeholder consultations during September and October 2014

Prior to any proposal plans being prepared, TGP met with stakeholders including Council Officers to discuss issues and gather information views and issues relating to Largs Town Centre and the Seafront. The emphasis was on the stakeholders identifying priorities which were then ranked. Strategy plans were then prepared and presented to the Largs Bid Team Officers and the councillors.

A meeting was also held with Transport Scotland at this stage.

See below for notes of consultations and points raised:-

Patricia Rowley – Structural Engineer (Flood Prevention Officer), North Ayrshire Council.

- Flooding associated with surface water. Main area of concern is Gogo Burn and areas around Stanlane Place and Crawford Street.
- Permeable surfacing and rain gardens to be incorporated if feasible.
- Sea defence walls assessment carried out with no structural issues found. Minor repairs recognised to sea defences along putting green.
- New and proposed sea defences to be constructed to NAC specification. Alteration of sea defence walls possible if the wall heights preserved. No issues with moving walls or turning them into seating terraces.

David Lodge – Team Manager, Transportation, North Ayrshire Council.

- David's responsibilities include public transport and car parking.
- New parking strategy available on NAC web page (David Hilditch).
- Possible future Park and Ride facility on the south outskirts of Largs.







Purpose:	To update the Committee on actions taken in relation to the list of projects and issues provided by the Chair.				
Recommendation:	That the Committee notes the update contained within the report.				

1. Introduction

1.1 In March 2015, the Chair of the North Coast Area Committee requested regular updates on a list of projects and issues pertinent to the North Coast area.

2. Current Position

2.1 Updates are provided on projects/issues of interest to the Area Committee as follows:

Largs Forestry Proposals

- 2.2 Members will be aware of significant forestry proposals extending some 140ha to the east of Largs at Halkshill and Blairpark. At the time of writing, the developer is amending their Environment Statement following further comments from Forestry Commission Scotland (FCS). The proposals will undergo statutory public consultation only after FCS is satisfied with the final draft of the Environment Statement. Latest indications are that this consultation will take place before the end of the year. Following close of consultation, FCS will review comments received and then either grant the proposals, subject to conditions, or refuse consent. There is an appeal process should the developer wish to appeal FCS's decision.
- 2.3 In terms of the hydro electric proposals reported to the Area Committee, both recently received full planning permission under delegated powers. They are at Greeto Water (817kW) and Gogo Water (500kW). Planning consents were issued to the Greeto Water and Gogo Schemes respectively on 24 July 2015 (ref:15/00167/PP) and 2 September 2015 (ref 15/00295/PP).

Business Development

2.4 As outlined in the report circulated on 13 August, 2016, Stuart Munro is the Business Growth Manager with direct responsibility for Largs and Cumbrae. Over the last six weeks Stuart has been building his networks within these communities and worked closely with the Largs BID team on the launch of Superfast Broadband in the town. He is also working to develop growth plans with a number of local businesses and providing assistance where appropriate/necessary.

3. Proposals

<u>A78</u>

2.2 Officers from Economy and Communities attend meetings of the Fairlie Safer Roads Group. The next meeting is scheduled for 13 October 2015, following a meeting between Kenneth Gibson MSP and Fergusson Coal. The Committee will be updated on any further issues following this meeting. Both the installation of traffic signals which are activated when vehicles exceed the speed limit, and a change to the road surface to lessen noise are both considered to have had a positive effect on traffic within Fairlie.

Shore Path

2.2 The following information provides an update on the Fairlie Community Links project:

Phase 1 - Coastal Path Bay Street to South Car Park

2.3 The public consultation on the Coastal Path started on Friday 28 August and will end on Friday 9 October. This includes:

- Electronic copies of the consultation documents on the Council website;
- Paper copies of the consultation documents in a number of local facilities;
- Meetings with interest groups including North Ayrshire Access Panel; and
- A public exhibition drop-in session in Fairlie Village Hall on Thursday 17 September from 11am to 3pm and 4pm to 7.30pm.
- 2.4 The Committee will be updated on the feedback obtained from the consultation process thereafter.

Phase 2 - South Car Park to Hunterston Roundabout

2.5 The third stages of the Cycle and Road Safety Audits are now complete. This has assessed the path as constructed to identify any potential hazards and recommend measures to remove or mitigate against any such hazards. A small number of measures have been identified and are being implemented by the contractor.

Radioactive Waste

2.6 The Scottish Environment Protection Agency (SEPA) is still considering EDF's application to vary its authorisation to dispose of radioactive waste at Hunterson B. The latest update from SEPA is that it hopes to make a decision by the end of 2015. However, the decision could be somewhat delayed depending on how quickly government bodies respond to a second round of consultation. This consultation is limited to the Scottish Government, the Office for Nuclear Regulation and Food Standards Scotland.

Hunterston

2.7 Members will be aware of the proposed closure of the Longannet Coal Power Station in Fife in March 2016. The station itself employs 230 staff, however its closure will also see a number of job losses at Hunterston from those currently employed by Clydeport (who service the transfer of coal through Hunterston and which serves Longannet). As well as the impact of the Longannet closure, the loss of employment is understood to be related to the introduction of the carbon tax announced in the recent budget. 2.8 The Scottish Government has recently set up a Longannet Task Force Operational Group which will draw up an economic recovery plan to support workers, businesses and communities affected by the closure of the station. The first meeting of the task force was recently chaired by the Energy Minister Fergus Ewing and the group is made up of elected representatives, trades unions, businesses, government agencies, neighbouring local authorities, the coal industry, trade unions and Scottish Power. Officers have secured the involvement of North Ayrshire Council and will ensure that sufficient focus is placed on community impacts in North Ayrshire.

1. Introduction

1.1 In March 2015, the Chair of the North Coast Area Committee requested regular updates on a list of projects and issues pertinent to the North Coast area.

2. Current Position

2.1 Updates are provided on projects/issues of interest to the Area Committee as follows:

Millport Conservation Area Regeneration Scheme (CARS)

2.2 No major update since the last Committee. The scheme will be launched early in 2016, and it will operate for a five year period thereafter. A specific officer will be appointed to take forward the CARS project. It is intended that retailers are consulted upon the nature of a shopfront improvement scheme in the Autumn.

Garrison Stables

2.3 No major update since the last Committee. Officers wrote to the owner of the property on 26 May 2015. At the time of writing, only a brief phone call from an individual acting on behalf of the property owner has been received. The Committee has previously been advised that, subject to correspondence with the owner not delivering sufficient progress, a specific proposal demonstrating a positive use for the building would be required to be in place to provide justification for the use of compulsory purchase processes. In exploring this, CCDC have also written to parties who have previously expressed interest in the use of the building. The case for any CPO would require to be approved by the Council, and ultimately be determined by the Scottish Government. In deciding whether to confirm a CPO Scottish Ministers would weigh up the public benefit in the proposals against the interests of the people affected.

Cumbrae Economic Development

- 2.4 A public consultation event was held on 31 August to discuss the proposed Cumbrae Economic Regeneration Plan. This event was attended by around 50 people from the local community/community groups, businesses, and partner agencies such as the Field Studies Council and Sport Scotland. The draft Economic Regeneration Plan which was presented at the event proposes a series of actions within the four themes of:
 - Economic infrastructure,
 - The visitor economy;
 - The Conservation Area Regeneration Scheme; and,
 - Community activity.
- 2.5 The event was successful in confirming the content of the economic plan, and saw good feedback and comment from those in attendance. Priorities emerging included the development of marine tourism facilities, the implementation of the CARS scheme including the provision of wet weather facilities. and the provision of accommodation on the Island. The event was attended bv representatives of Complete Solutions Ltd who are developing proposals for the Westpoint Holiday Village and who will also present the the Area Committee.
- 2.6 Further to the event the draft plan will be finalised and circulated for comment to those who attended the workshop and anyone else who requires a copy. Thereafter it is envisaged that a group will be formed to drive forward the implementation of the plan, ensuring appropriate focus of those involved and facilitating improved joint working. Representation from appropriate community groups, partner agencies, local businesses, etc and an appropriate chair will be sought.

Millport Field Centre

2.7 Officers continue to support the Field Studies Council (FSC) in their operation of the Millport Field Centre. The new teaching and accommodation facilities developed with the assistance of North Ayrshire Council, Highlands and Islands Enterprise and Scottish Government were opened on 1 July 2015. Officers also attended the launch of the Year of Fieldwork on 14th September which received extensive press coverage. The FSC are currently tendering works to allow the refurbishment of the previously existing teaching and accommodation facilities at the site. This will see the implementation of a further package of works that will extend to over £1m funded by a range of sources secured with the assistance of the Council.

<u>Other</u>

2.8 Officers also continue to explore the potential for investment in additional accommodation facilities on the Island through proposals emerging at both the Westpoint Village and George Hotel.

The group was set up to raise awareness and promote the concept of fairtrade. The group were instrumental in ensuring Fairlie was awarded Fairtrade Village status in 2004, and 2009 and also again in 2013 when it was renewed.

Members have developed links with a range of church groups and other voluntary organisations. They became affiliated to the Scottish Fair Trade Forum and Fair Trade Foundation (UK umbrella organisation) in 2008, and were instrumental in assisting Fairlie Parish Church to secure Fairtrade Church status in 2010.
