**1. Civic Government (Scotland) Act 1982: Taxi Numbers Limitation**

Submitted report by the Assistant Chief Executive (Legal and Protective) on applications for taxi licences in respect of Zone 2 (Ardrossan/Saltcoats/Stevenston) where all licences are currently allocated.

In terms of Section 10 of the Civic Government (Scotland) Act 1982 the licensing authority may refuse to grant applications for taxi licences in order to limit the number of taxis "if but only if, they are satisfied that there is no significant demand for the services of taxis in the area which is unmet". North Ayrshire Council, as Licensing Authority, has agreed limitations on the number of taxi vehicle licences it is prepared to grant and the Council area is divided into Zones for the purposes of these limitations. Zone 2 is the Ardrossan/Saltcoats/Stevenston area and the numbers limitation for that Zone is 83. All taxi licences within the Zone have been allocated.

In September 2002 the Council received two applications for taxi vehicle licences (TL/500 & TL/501) in Zone 2. Both applications relate to taxi vehicles which are wheelchair accessible. These applications were considered by Sub Committee at the meetings held on 21st October and 11th November 2002 respectively. In both cases the Sub Committee agreed to proceed to a Hearing and to advertise the application in terms of Paragraph 2 (7) (c) of the Civic Government (Scotland) Act 1982.

The applicant who had submitted both applications was present at the meeting and was represented. The Chief Legal Officer (District Court and Licensing) set out the background to the Hearing as previously intimated to the applicant. The applicant and his representative then addressed the Sub Committee in support of the applications and in terms of unmet demand for wheelchair accessible taxi vehicles in Zone 2.

The Sub Committee agreed to (a) increase the taxi numbers limitation for Zone 2 - Ardrossan/Saltcoats/Stevenston from 83 to 85 licences; and (b) grant applications TL/500 and TL/501.

## **2. Gaming Act 1968**

Submitted report by the Assistant Chief Executive (Legal and Protective) on applications received under Section 34 of the Gaming Act 1968 for permits for gaming machines.

The Sub Committee agreed to grant permits in respect of the following applicants:-

## **4. Civic Government (Scotland) Act 1982: Taxi Driver Licences**

Submitted report by the Assistant Chief Executive (Legal and Protective) on proposed variations of licensing conditions attached to taxi driver licences presently in force.

In terms of the procedure to deal with variations to licences, the Council as Licensing Authority is required to grant a Hearing to each licence-holder to consider any representations they may have in respect of any proposed variation to the conditions attached to their licence. 261 licence-holders, as set out in attached Appendix LS1, were cited to attend the meeting.

The holder of licence TDL/685 was present at the meeting and sought clarification in respect of the application of new condition 3 prohibiting smoking in taxi vehicles. The Assistant Chief Executive was heard in explanation that this condition applied only to the times when the vehicle is being used as a taxi, and not to times when it is being used privately.

The Sub Committee agreed to vary the conditions attached to taxi driver licences presently in force, as set out in the attached Appendix LS1, in accordance with Paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act 1982.

#### **5. Civic Government (Scotland) Act 1982: Applications for Licences**

Submitted report by the Assistant Chief Executive (Legal and Protective) on (a) applications for the grant or renewal of licences; (b) issues in respect of existing licence-holders which may require a Hearing; and (c) Hearings which require to be determined by the Sub Committee.

The Sub Committee agreed to dispose of these matters as indicated in the attached Appendix LS2.
