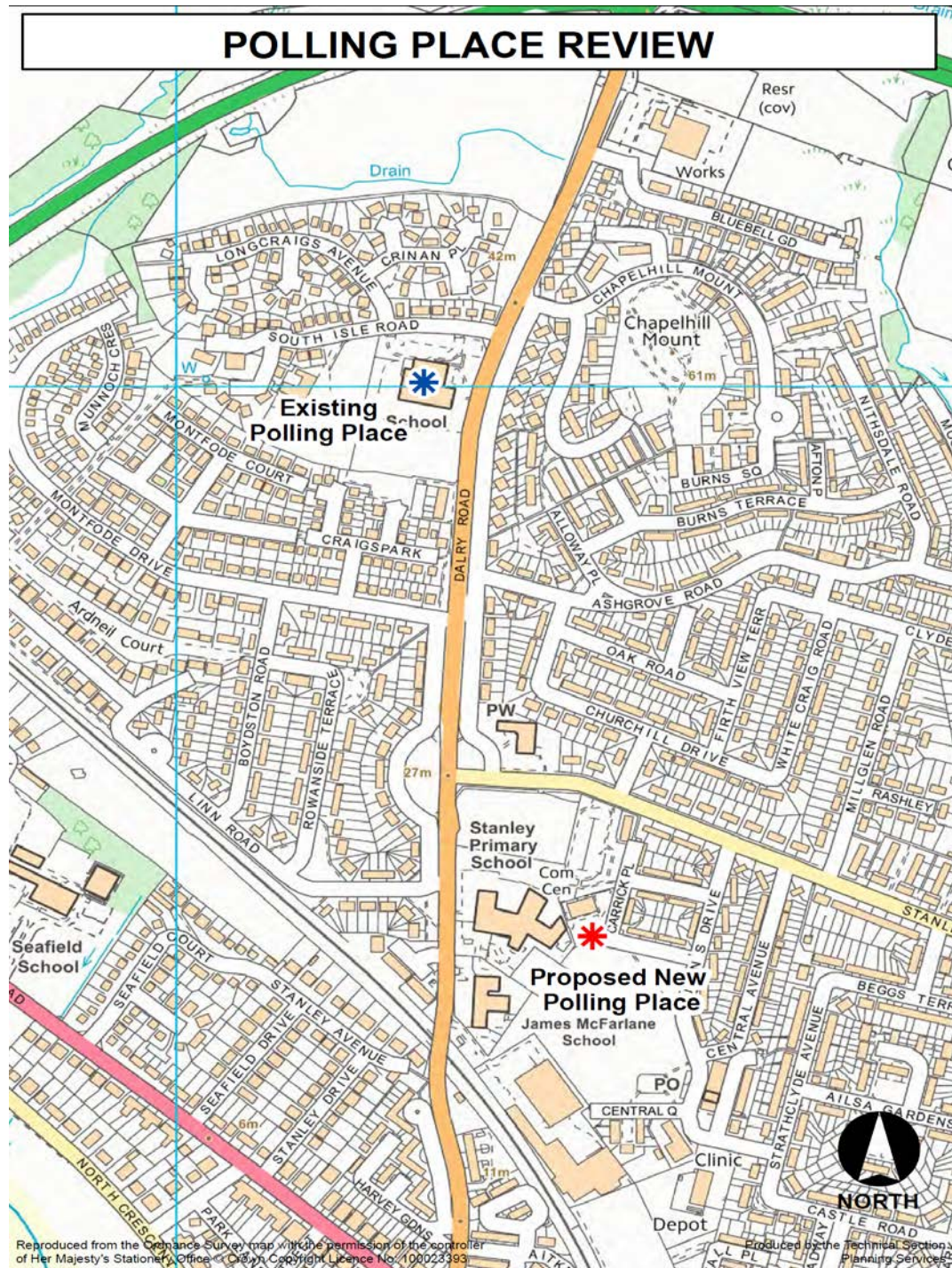

Existing - St Peter's Primary School

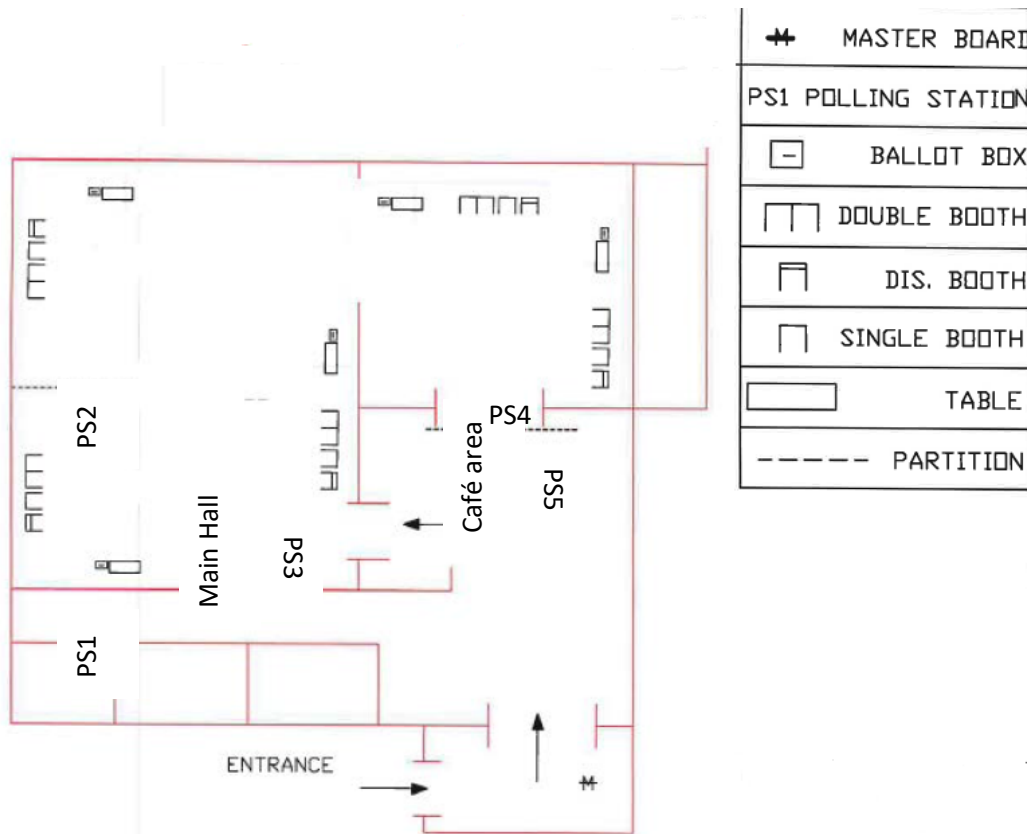
Proposed New - Whitlees Community Centre

<ul style="list-style-type: none"> <li>If multiple polling stations need to be provided, are there other rooms available, or can the space be clearly divided to provide adequate room for more than one polling station?</li> </ul>	Yes	Hall can easily accommodate 6 polling stations. Hall can also be extended into cafe area if necessary, accommodating 2 further stations.
<ul style="list-style-type: none"> <li>Is there sufficient space inside the polling station to comfortably accommodate staff, voters, polling agents and observers?</li> </ul>	Yes
